1.5 Subp. 4. **Application procedures for wolf license.**

1.7 F. A person selected through the wolf permit drawing must purchase the license
1.8 no later than ~~the day prior to the start of the season for which the applicant is selected.~~
1.9 October 24 if selected for the early season or November 15 if selected for late season
1.10 hunting or late season trapping. Any licenses not purchased by the deadlines shall be
1.11 issued following the procedures in item G.

1.12 G. Wolf licenses that are not purchased by the deadlines described in item F
1.13 shall be offered for sale as follows:

1.14 (1) unsuccessful wolf license applicants may purchase unsold wolf licenses
1.15 on a first-come, first-served basis beginning at 12:00 p.m. on October 29 for the early
1.16 season and beginning at 12:00 p.m. on November 19 for late season hunting and late
1.17 season trapping. An eligible person must apply individually and in person at an ELS-POS
1.18 (point of sale) agent location or individually through the ELS-Internet or ELS-Telephone
1.19 system to obtain a remaining license; and

1.20 (2) any remaining available licenses not purchased by unsuccessful
1.21 applicants may then be sold to any eligible person on a first-come, first-served basis
1.22 beginning at 12:00 p.m. on November 1 for the early season and beginning at 12:00
1.23 p.m. on November 21 for late season hunting and late season trapping. An individual
1.24 may purchase one wolf license annually.

2.1 ~~G.~~H. All applicants must furnish proof of a current or previous year hunting
2.2 license as required by Minnesota Statutes, section 97B.647, subdivision 6, and as specified
2.3 in the application instructions.
