1.5	Subpart 1. Open period. Canada geese may be taken from August 9 to 24.
1.6	Subp. 2. Open area. Canada geese may be taken in that portion of the state lying
1.7	within the following boundary: Beginning at the junction of U.S. Highway 2 and the North
1.8	Dakota boundary, Polk County; thence along U.S. Highway 2 to Minnesota Highway 32;
1.9	thence along Minnesota Highway 32 to Minnesota Highway 92; thence along Minnesota

2.2	A. A fall special goose permit is required to take geese under this part.
2.3	B. To purchase a fall special goose permit, hunters must not have their small

2.7	Subp. 5. Penalties. A violation of this part or the conditions of any permit issued
