Subp. 3. **Registration of pelts.** The pelt of each bobcat, fisher, pine marten, and otter must be presented, along with completed site validation coupons for each fisher, pine marten, or otter, by the person taking it, to a state wildlife manager designee for registration before the pelt is sold and before the pelt is transported out of the state, but in no event more than 48 24 hours after the season closes for each species, respectively fisher and marten and 48 hours after the season closes for otter and bobcat. The entire carcass of bobcat and the entire head of pine marten and fisher must be surrendered to the state wildlife manager designee. The pelt of bobcat, otter, fisher, and pine marten must have been removed from the carcass.
