1.9 F. The Sandstone Wildlife Management Area in Pine County is closed to
1.10 firearms hunting for deer and bear, but open to archery hunting for deer and bear and
1.11 hunting and trapping of all other species by legal means during designated seasons.

1.12 Subp. 12. **Sanctuary areas open to ~~hunting~~.** The following sanctuary areas of
1.13 wildlife management areas posted with "Wildlife Sanctuary Do Not Trespass" signs are
1.14 open for ~~hunting~~ as specified:

1.20 D. The posted sanctuary within the Ricehaven Wildlife Management Area in
1.21 St. Louis County is open:

1.22 (1) May 1 through September 14 for wild rice harvest during the wild rice
1.23 season, canoeing, and bird watching; and

2.1 (2) November 25 through May 15 for hunting and trapping of any species
2.2 for which there is an open season.

2.4 **6230.0250 GENERAL PROVISIONS FOR USE OF WILDLIFE MANAGEMENT**
2.5 **AREAS.**

2.7 Subp. 7. **Overnight use.** A person may not camp on or remain in a vehicle overnight
2.8 in any wildlife management area, except by permit or where posted for this use by the
2.9 commissioner. A person may not leave a vehicle, trailer, or tent unoccupied or unattended
2.10 overnight within a wildlife management area, except by permit or in areas and at times
2.11 designated by signs for overnight use. A vehicle, trailer, or tent lawfully left overnight
2.12 must be occupied or attended. A person may not make noise at a level above that of a
2.13 quiet conversation in camping areas from one hour after sundown to one hour before
2.14 sunrise, which are designated quiet hours.

2.16 **6230.0295 VERMILLION HIGHLANDS WILDLIFE MANAGEMENT AREA.**

2.17 Subpart 1. **Hunting.** The Vermillion Highlands Wildlife Management Area located
2.18 in Dakota County is closed to all hunting and trapping except:

2.19 A. archery, firearms, and muzzleloader deer hunting by special permit only;

2.20 B. pheasant and Canada goose hunting starting on the day following the close
2.21 of the muzzleloader deer season through the end of the respective statewide seasons;

2.22 C. trapping and predator hunting beginning January 1 by special permit only; and

2.23 D. spring turkey hunting.

3.1 Subp. 3. **Dogs.** Dogs must be on a leash except when hunting pheasant or Canada
3.2 goose during the designated season.

 4.23 of the landowner.

5.10 D. deer hunting by firearms.

5.12 **6234.0600 TAKING JACK RABBITS, COTTONTAIL RABBITS, AND**
 5.13 **SNOWSHOE HARES.**

5.15 Subp. 2. **Bag limits.** A person may not take more than ten cottontail rabbits, ~~jack~~
 5.16 ~~rabbits~~, and snowshoe hares, combined, per day or possess more than 20 cottontail rabbits,
 5.17 ~~jack rabbits~~, and snowshoe hares, combined, at a time. A person may not take more than
 5.18 one jack rabbit per day or possess more than three jack rabbits, combined, at a time.

5.19 **6234.1700 TAKING FISHER AND PINE MARTEN.**

5.20 Subpart 1. **Open season.** Fisher and pine marten may be taken by trapping from the
 5.21 first Saturday following Thanksgiving ~~to the Sunday nearest~~ through December 12.

5.22 Subp. 2. **Bag limits.** The combined limit for fisher and pine marten is ~~five~~ two per
 5.23 season, in aggregate. A person may not take more than ~~five~~ two fisher and pine marten,
 5.24 combined, per season or possess more than ~~five~~ two fisher and pine marten, combined, at

6.1 a time, except that a person may possess additional pelts that the person lawfully took,
6.2 tagged, and registered during previous seasons.

6.4 **6234.2600 PELT TAGGING AND REGISTRATION.**

6.6 Subp. 3. **Registration of pelts.** The pelt of each bobcat, fisher, pine marten, and
6.7 otter must be presented, along with completed site validation coupons for each fisher,
6.8 pine marten, or otter, by the person taking it, to a state wildlife manager designee for
6.9 registration before the pelt is sold and before the pelt is transported out of the state, but
6.10 in no event more than ~~48~~ 24 hours after the season closes for ~~each species, respectively~~
6.11 fisher and marten and 48 hours after the season closes for otter and bobcat. The entire
6.12 carcass of bobcat and the entire head of pine marten and fisher must be surrendered to
6.13 the state wildlife manager designee. The pelt of bobcat, otter, fisher, and pine marten
6.14 must have been removed from the carcass.

6.18 Subp. 4. **Open areas.** Wild turkey permit areas are open for the fall turkey season as
6.19 prescribed by the commissioner. Turkey licenses are valid for taking turkeys only in the
6.20 wild turkey permit area specified on the license, except youth licenses, which are valid
6.21 statewide. The following wild turkey permit areas are open for the 2016 fall season: 501,
6.22 502, 503, 504, 505, 506, 507, 508, 509, 510, 511, and 512.

7.1 **REPEALER.** Minnesota Rules, part 6230.0295, subpart 2, is repealed. The emergency
7.2 amendments to Minnesota Rules, parts 6230.0200, 6230.0295, 6230.0400, and 6234.0600,
7.3 published in the State Register, volume 40, page 105, August 3, 2015, are repealed.

7.4 **EFFECTIVE PERIOD.** The emergency amendments to Minnesota Rules, parts
7.5 6234.1700, 6234.2600, and 6236.0700, expire December 31, 2016. The emergency
7.6 amendments to Minnesota Rules, parts 6230.0200, 6230.0250, 6230.0295, 6230.0400,
7.7 and 6234.0600, expire August 15, 2017. After the emergency amendments expire, the
7.8 permanent rules as they read prior to those amendments again take effect, except as they
7.9 may be amended by permanent rule.
