7.2 Subpart 1. Open season. Fisher and pine marten may be taken by trapping from the
7.3 first Saturday following Thanksgiving to the Sunday nearest December 12 through November

Subp. 2. Bag limits. The combined limit for fisher and pine marten is five two per
season, in aggregate. A person may not take more than five two fisher and pine marten,
combined, per season or possess more than five two fisher and pine marten, combined, at
a time, except that a person may possess additional pelts that the person lawfully took,

The pelt of each bobcat, fisher, pine marten, and otter 7.13 must be presented, along with completed site validation coupons for each fisher, pine marten, 7.14 or otter, by the person taking it, to a state wildlife manager designee for registration before 7.15 the pelt is sold and before the pelt is transported out of the state, but in no event more than 7.16 48 24 hours after the season closes for each species, respectively fisher and marten or 48 7.17 hours after the season closes for otter and bobcat. The entire carcass of bobcat and the entire 7.18 head of pine marten and fisher must be surrendered to the state wildlife manager designee. 7.19 The pelt of bobcat, otter, fisher, and pine marten must have been removed from the carcass. 7.20
