- * Length At Capture With Last Incremental Length report: The following criteria must be met for a report to be generated:
 - 1. The fish species must have an assigned body scale constant.
 - 2. Fish must have an "official" age assigned.
 - 3. Fish must have a digitized measurement marked for back calculation use.

Note: The data source for Length and Age Class Frequency Distribution tables is updated twice daily - once at noon and once overnight. Any changes to the data made after noon on 05/02/2014 may not be reflected in the Distribution tables until 05/03/2014.
