A regional park should be 100+ acres with some exceptions, serve a regional clientele and provide outdoor recreation facilities and activities that are primarily natural resource based. <a href="#"><u>Federal Recreational Trail</u></a>	Cities, Counties, Townships, Recognized Tribal Governments, Private Trail Organizations sponsored by a Local Unit of Government	Acquisition, development, redevelopment and/or maintenance of motorized (snowmobiles, off-highway motorcycles, all-terrain vehicles and four-wheel drive trucks) and non-motorized (hike, bike, mountain bike, ski, horse, in-line skate) trail, trailside or trail head projects.
