This project will enhance wildlife habitat at Lake Bella Park, located on the Iowa boarder south of Worthington, Minnesota. The park belongs to the Okabena-Ocheda Watershed District and is open to public hunting. Lake Bella Park is bordered by the Lake Bella WMA (106.3 acres), the Lake Bella WPA (72.6 acres) and numerous privately owned acres in CRP contracts and 45 year CREP II easements.

This project will enhance approximately 68.4 acres of grassland in Lake Bella Park. The grassland to be enhanced now contains largely non-native cool season grasses with occasional native and non-native forbs intermixed. Approximately 65 acres of area to be seeded are infested with pocket gophers. These areas will need to be leveled with tillage before other ground preparation and seeding can take place.

This project will plant local a ecotype seed mix of 25 or more species of native grasses and forbs. Ground preparation will begin in July 2010 and seed planted during spring 2011.

The site will be mowed up to two times in 2011 and once in 2012 to aid establishment of the native prairie vegetation. Spot spraying and mowing will be used when needed during the first three years after planting to discourage non-native grasses and noxious weeds. The land will be managed long-term with prescribed burns to maintain healthy and diverse native vegetation.

 The Okabena-Ocheda Watershed District Board of Managers owns and manages Lake Bella Park. The District Administrator will be the long-term manager for the site.

It is likely that the areas enhanced by this grant will need to be mowed once during the summer of 2012 to aid establishment of the grasses and forbs. Noxious weeds will need to be mowed or spot sprayed during the establishment period. The site will be managed long-term with prescribed burns to maintain healthy and diverse vegetation.

- c. Who will complete this maintenance work, and how will it be funded?
 Maintenance work will be completed by District staff, managers or hired contractors. The work will be funded by the watershed district levy.
- d. Will the CPL funds supplant any existing funds?The CPL funds will not supplant existing funds.


