This project will in essence permanently protect and enhance20 acres of grassland buffer and several acres of type 1 and type 2 wetlands. In the process of protecting these acres of grassed buffer and wetlands we will also be enhancing the buffering qualities of grassed areas by ceasing the haying of the area and expanding the buffer area in several locations. This protection and enhancement will provide a larger more suitable block of wildlife habitat specifically for the Topeka Shiner and Blandings Turtle that are on the endangered species listing for this region of the state.

This projects benefit includes the protection and enhancement of 20 acres of habitat as well as buffering a stream part of the Rock River watershed. The Rock River Watershed is currently listed as impaired for Fecal Coliform and Turbidity. The buffering qualities of the grasses and wetlands in the easement area will benefit both impairments in this reach of
the Rock River Watershed. The wildlife habitat will benefit the Topeka Shiner and Blandings Turtle that are on the endangered species listing for this region of the state.


