<b>Summary:</b> Victim/shooter loading shotgun while stepping out of vehicle when he slipped on wet grass causing gun to discharge into victim's calf.

Summary: Victim out of sight of shooter receiving a gunshot wound to upper thigh from a ricocheted pellet.

Summary: Victim/shooter putting cell phone away causing gunshot wound to his foot.
