

INSTRUCTIONS FOR THOSE APPLYING TO BECOME A MNDNR APPROVED FIREWOOD VENDOR

1. To become a MNDNR approved firewood vendor, fill out an application form and take the signed form to your nearest MNDNR Forestry office (southwest vendors can take their application to either Camden or Nerstrand State Park). The forester (or Park staff) will review your application and if complete and accurate, will approve it. They will then send your application to the MNDNR Central Office to be entered into the public website. Once approved, the forester will give you a sheet of MNDNR approved vendor tickets. You may use them to label your bundles, or you may add "MNDNR approved" to your own bundle labels. Because data entry may take one to two wks, please verify that you are on the public list before distributing your approved firewood. Otherwise, your customers risk being asked to leave the MNDNR facility or surrender their wood because your name is not yet on the official list of approved vendors.
2. Fill out a separate application form for each county from which you harvest wood. Applications with more than one county listed will be approved for only the first county listed. Vendors applying to approve wood from multiple counties must keep wood from different counties separate so the firewood can be sold for use on only those MNDNR facilities for which each county source has been approved.
3. Vendors harvesting firewood from multiple sites within the same county and within 50 miles of each other may enter the township, range and section on the application of the harvest site most central to that cluster of sites. MNDNR facilities at which the wood can be used will be determined by the location of that one site.
4. Fill out a separate application form for each type of firewood (Option A versus Option B) that you intend to have MNDNR approved. Vendors with more than one type of firewood checked on their application will be approved for only the first type listed (option A). Vendors selling both option A and option B firewood must keep option A wood and option B wood separate so the firewood can be sold for use at only those MNDNR facilities for which that type of wood has been approved. Applications for Option B firewood must include the appropriate documentation to prove Minnesota Department of Agriculture (MDA) certification. 5. Be sure to fill in both the business name and the contact person on your application. MNDNR approved vendors are defined as businesses or individuals selling firewood to the public for use on MNDNR administered lands. Private individuals using their own firewood on MNDNR administered lands are not considered vendors and may not apply to become approved vendors.
6. Select the option under which you are applying to become an approved firewood vendor.
 - a. Option A allows you to sell any non-ash firewood harvested within Minnesota without additional processing or treatment, as long as the wood was harvested within 50 miles of the MNDNR facility where it is to be used.
 - b. Option B allows you to sell firewood anywhere in the state that has been certified by the MDA. Upon certification, the vendor is authorized to use the MDA certification shield on their firewood label. Note: MDA certified vendors must apply to become MNDNR approved vendors.
7. For untreated firewood, be sure to fill in the county, township, range and section (the legal description) of the land where the wood was harvested.
8. Read the statements at the bottom of the application before signing the document. Knowingly providing false information or taking wood onto a MNDNR facility for which it is not approved is a misdemeanor punishable by a fine or jail sentence.
9. All applications must be renewed every year by October 15th.

To sell approved firewood, you must agree to the following:

1. I will provide proof of purchase to all customers at the time of sale. Proof of purchase may be the MNDNR "Approved Firewood Vendor" ticket provided by the approving DNR forestry office, sales receipt or firewood label that includes business name, address, telephone number, date and quantity of wood.
2. If my wood originates from an emerald ash borer-quarantined county in MN, I will contact the Minnesota Department of Agriculture to discuss obtaining a compliance agreement. There are two options for vendor supplied approved firewood. Please indicate your option by initialing the one that applies to the firewood you will sell for use on MNDNR-administered lands.

(initials) A. The non-ash firewood I am selling originated in MN and was harvested within 50 miles of the MNDNR-administered lands (such as a state park or state forest campground) for which I am applying to be an approved firewood vendor.

Fill out a separate application for each county in which your firewood was harvested. If you include more than one county on your application, it will be approved for only the first county listed. Note: vendors harvesting wood from multiple counties are expected to separate and manage wood piles to comply with the terms of this application.

On the back of this application, check all DNR facilities for which you are applying. They must be within 50 miles of your harvest site. Applications without the DNR facilities checked will not be considered.

B. The firewood I am selling originated in MN and has been certified by the MN Department of Agriculture. To be considered, a copy of the documentation verifying certification **must** be attached to this application.

Fill out a separate application for each type of firewood (Option A or Option B) for which you are applying. If you include more than one type of firewood on your application, it will be approved for only the first type of firewood listed (Option A). Note: vendors with multiple types of firewood are expected to separate and manage wood piles to comply with the terms of this application.

By signing below, I declare that:

- I understand that it is unlawful to sell firewood for use on DNR-administered lands unless I am an approved firewood vendor and agree to the above requirements. I also understand I must follow all state laws concerning firewood, including labeling requirements (MN Statute 239.093 (c) 2007) and quarantine restrictions (**State Emergency Quarantine, No. RF-1036**).
- I understand that this approval must be renewed every year no later than October 15th.
- I hereby certify that the information I have provided is true and I agree to abide by all requirements
