Hi Patrice, recall that I put together WQ-related comments on the previous (pre-publication) draft EAWs for this project and, per your suggestion, sent those directly to DNR staff back in February and again in April. The attached email contains those comments. My review of this final, published EAW, led me to conclude that the DNR staff did a good job including, or at least addressing, most of those suggestions, in some instances using my text verbatim.

That said, I do have one additional comment, which relates to my own oversight. When I provided the WQ standards to list in the EAW (see Item 11a.i.), I regrettably forgot to add an additional sentence or two identifying that the more restrictive Lake Superior Basin WQ standards in Minn. R. ch. 7052 (for certain parameters) also apply to this project. For Class 2B waters (this project), those are listed in the table at 7052.0100, Subpart 5 <u>https://www.revisor.mn.gov/rules/?id=7052.0100</u>. For example, the more restrictive applicable total mercury standard of 0.0013 ug/L (more conventionally referred as 1.3 ng/L) is listed here, not in 7050.

So their ER record will be accurate, I advise pointing this out to them in your comment letter. Perhaps a comment that says something like the following will do the trick: "In addition to the MPCA WQ standards already responsibly identified in the EAW at Item 11.a.i., the more restrictive WQ standards for the parameters listed at Minn. R. 7052.0100, Subp 5, also apply to this waterbody."

That's all on my end.
