Hello,

I am wondering if the possibility of leaving the damaged structures at Blue Mounds is a possibility since it has created wildlife habitat for larger snake species such as native western fox snakes? When I participated in the Minnesota Herpetological Society field survey in June, 2017 we found multiple adult fox snakes in the old concrete structures including gravid females which use the broken dam structure as cover and a refuge to thermoregulate. Would there be consideration for safely removing snakes from the structure as it is broken up? Could the broken dam be left as it is and the trail and new dam be diverted slightly up or downstream? I thought these animals worth considering in your environmental review. DNR staff Jeff LeClere should have put together a report of the species found at Blue Mounds and the usefulness of the old dam structure for wildlife habitat.
