

## 2017 Request for Help Stop Aquatic Hitchhikers! Signs

The Minnesota Department of Natural Resources (DNR) provides a limited number of “**Help Stop Aquatic Hitchhikers!**” signs for lake associations, local governments, and other groups to post at water accesses.

You may request up to **four** standard signs (18” x 24”) OR **two** standard signs plus **two** large signs (4’ x 3’) per calendar year. The DNR has a limited number of signs available, so our ability to fulfill your request will depend on regional availability. If signs are available, we will provide them at no cost to you. We do not provide sign posts or other materials.

1. Receive permission from the water access owners. Find ownership information using [LakeFinder](#).
2. Complete the form below (pgs. 1 & 2) and email, mail or fax it to your [DNR Invasive Species Specialist](#).
3. Review the [Aquatic Invasive Species Sign Manual](#) for installation guidelines.
4. Submit the AIS Sign Installation Report Form (pg.3) to the DNR within 60 days of sign installation.
