## Wildlife Manager Report

Deer Permit Area (DPA) 182 is an urban/suburban area that includes the cities of Duluth, Hermantown, Proctor, Esko and Cloquet. This DPA is primarily private land, so harvest is mostly dictated by access to private land and the harvest desires of the landowners. There is no population model in this DPA due to its small size. This unit has been designated as Three-deer limit every year since 2005. Harvest levels have remained remarkably constant from year to year, and buck harvest success rates are among the highest in the Cloquet area. DPA 182 will remain as a Three-deer limit designation in 2023.




