### Wildlife Manager Report

Deer Permit Area (DPA) 236 is set within southeast Anoka County, northern Washington County, and southern Chisago County. The southern area is highly developed and borders the metro deer management area (DPA 701) with a five-deer bag limit. DPA 236 population has consecutively grown in density even with more liberal harvest designations. Another year of early antlerless and a three-deer limit should help curb the growth rate with focused antlerless harvest to stabilize the population at goal level.

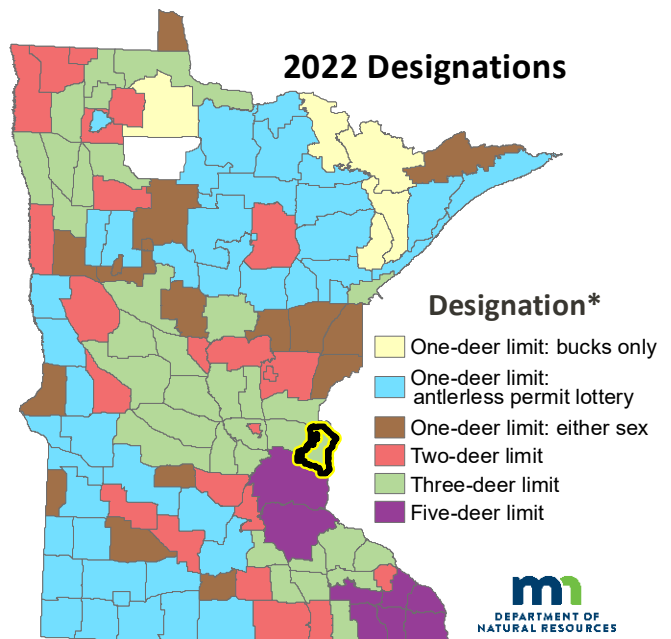
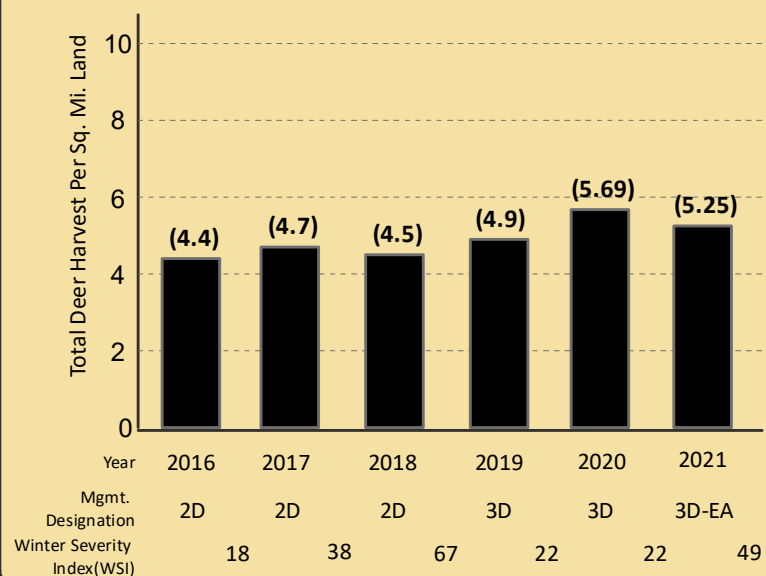
