If you do *not* give us your SSN or a certification, we cannot issue you a game and fish license. The federal law is Title IV-D of the Social Security Act, U.S.C., Title 42, section 666(a) (13).

* The DNR is required to provide your SSN or certification to the Minnesota Department of Human Services for child support enforcement purposes.
