This application is for **Minnesota residents** that are military personnel of the United States. The below licenses are provided to all eligible military personnel at no charge.

NOTE: For lottery area preference for resident military, see [Resident Military Preference Application](#) for eligibility.

Eligible Applicants:

On-leave personnel who is serving in the U.S. Military and stationed outside the state.

No License Required for Small Game No Minnesota Waterfowl Stamp or Pheasant Stamp is needed but must have a Federal Migratory Bird Stamp to hunt waterfowl.

If you apply for a game and fish license and you do not have an SSN, you must send us a certification that you do not have an SSN. If you do *not* give us your SSN or a certification, we cannot issue you a game and fish license. The federal law is Title IV-D of the Social Security Act, U.S.C., Title 42, section 666(a)(13).

* The DNR is required to provide your SSN or certification to the Minnesota Department of Human Services for child support enforcement purposes.

NOTE: Proof of MN residency and a copy of the official leave and/or discharge papers must be submitted with this application.

- Proof of MN residency and official leave and/or discharge papers must be carried on their person while fishing and/or hunting.
- Licenses/tags are valid upon issuance.
