This expedited emergency game and fish rule package discontinues the shining and night time hunting provisions of the disease management expedited emergency game and fish rule package previously published March 31 2008, beginning August 1 2008. August 2008 is the last month that earlier rule package was effective. Both disease management rule packages mentioned in this note expire August 31 2008.

1.2 **Adopted Expedited Emergency Game and Fish Rule: Disease Management Repeal**

1.3 **6232.0350 DISEASE MANAGEMENT.**

1.4 Subpart 1. **Private land open season.** An owner or tenant of land or an agent
1.5 designated in writing by an owner or tenant of land in the landowner/tenant shooting zone,
1.6 as defined in part 6232.4700, subpart 1a, may take deer on their land by archery, firearms,
1.7 or muzzle loader ~~at any time~~ from one-half hour before sunrise to one-half hour after
1.8 sunset in the landowner/tenant shooting zone.

1.9 Subp. 2. **Restrictions.** Deer taken in the landowner/tenant shooting zone must be
1.10 harvested according to rules and statutes that apply during the regular firearms, archery,
1.11 and muzzle loader seasons with the following exceptions.

1.12 A. deer of any age or sex may be taken without limit or license;

1.13 B. a tag with the following information must be attached to the deer prior to
1.14 transport from the landowner's or tenant's property: landowner's or tenant's name, the
1.15 township, range, and section where the deer was killed, and the date of the kill;

1.16 C. deer must be field dressed at the time of the kill. Carcasses must be presented
1.17 to the Wannaska Forestry Office, Grygla Forestry Office, or Thief Lake Wildlife Office
1.18 within 48 hours after taking or as otherwise approved by the commissioner;

1.19 D. deer carcasses may not be transported outside the landowner/tenant shooting
1.20 zone before being presented according to item C, except to be presented at the Wannaska
1.21 Forestry Office or the Thief Lake Wildlife Office. A possession permit is required to
1.22 possess deer or parts of deer under this part after presentation at one of the offices listed
1.23 in item C;

2.1 E. wearing blaze orange is not required, except during any open deer hunting
2.2 season when anyone taking deer must wear blaze orange one-half hour before sunrise to
2.3 one-half hour after sunset;

2.4 F. shooting from stationary motor vehicles is allowed, except from a public
2.5 roadway; and

2.6 G. ~~artificial lights are allowed~~ the antlers from any antlered deer taken by
2.7 owners or tenants of land or their agents must be turned over to the Thief Lake area
2.8 wildlife manager to be retained by the state.

2.9 **EFFECTIVE PERIOD.** The expedited emergency amendments to Minnesota Rules,
2.10 part 6232.0350, are effective August 1, 2008, to August 31, 2008.
