1.10	associated tributaries to the posted boundaries, all walleye in possession must be less than
1.11	18 inches in length or greater than 28 inches in length. All walleye that are 18 to 28 inches
1.12	in length, inclusive, must be immediately returned to the water.
1.13	B. If walleye kill estimates for winter and open water fishing are 205,750
1.14	pounds or less on June 30, then the size limit changes according to subitems (1) and (2):

1.17	greater than 28 inches in length; and
