1.23 **6236.1075 SPECIAL HUNTS FOR MILITARY PERSONNEL.**

1.24 For the 2013 spring wild turkey season, the following permits are available for special
 1.25 hunts for military personnel:

2.1 A. For Camp Ripley Military Reservation, within wild turkey permit area 507, up to
2.2 an additional 60 permits are available during time period C and another 60 permits during
2.3 time period D. The Minnesota Army National Guard is the sponsoring organization.

2.4 B. For Arden Hills Army Training Site, within wild turkey permit area 510, up to an
2.5 additional 20 permits are available for time periods A and C. The Department of Military
2.6 Affairs is the sponsoring organization.

2.7 **6236.1080 SPECIAL DISABILITY HUNTS.**

2.8 For the 2013 spring wild turkey season, the following permits are available for
2.9 disability hunts.

2.10 A. For wild turkey permit area 507, one additional permit per time periods A to
2.11 D are available for individuals with disabilities participating in a special hunt on the
2.12 Sand Prairie Wildlife Management Area. Midwest Outdoors Unlimited is the sponsoring
2.13 nonprofit organization.

2.14 B. For Camp Ripley Military Reservation, within wild turkey permit area 507,
2.15 46 additional permits are available for time period B for individuals with disabilities
2.16 participating in a special hunt. One nonhunting mentor shall accompany each disabled
2.17 hunter. The St. Cloud Veterans Administration is the sponsoring organization.

2.18 C. For wild turkey permit area 507, two additional permits per time periods A and C
2.19 are available for individuals with disabilities participating in a special hunt at the Prairie
2.20 Woods Environmental Learning Center. Midwest Outdoors Unlimited and Prairie Woods
2.21 Environmental Learning Center are the sponsoring nonprofit organizations.

2.22 D. For wild turkey permit area 507, one additional permit per time periods A to
2.23 D are available for individuals with disabilities participating in a special hunt on the
2.24 Sherburne National Wildlife Refuge. Midwest Outdoors Unlimited is the sponsoring
2.25 nonprofit organization.

3.1 E. For wild turkey permit area 508, one additional permit per time periods A to D
3.2 are available for individuals with disabilities participating in a special hunt on the Crane
3.3 Meadows National Wildlife Refuge. Midwest Outdoors Unlimited is the sponsoring
3.4 nonprofit organization.

3.5 F. For wild turkey permit area 507, 11 additional permits per time periods A to C and
3.6 14 additional permits for time period D are available for individuals with disabilities
3.7 participating in a special hunt. Midwest Outdoors Unlimited is the sponsoring nonprofit
3.8 organization.

3.9 G. For wild turkey permit area 508, two additional permits per time periods A and
3.10 C are available for individuals with disabilities participating in a special hunt on the
3.11 Benton County Bend in the River Park. Midwest Outdoors Unlimited is the sponsoring
3.12 nonprofit organization.

3.13 **REPEALER.** Minnesota Rules, part 6236.1060, published in the State Register, volume
3.14 37, page 845, December 3, 2012, is repealed.

3.15 **EFFECTIVE PERIOD.** Minnesota Rules, parts 6236.1060 and 6236.1075, expire July
3.16 1, 2013.
