 1.17 possess a valid permit for the following special hunt areas authorized for the 2014 season:

 1.20 to 3 for taking antlerless deer and legal bucks. ~~Camp Ripley Military Reservation is open~~

 1.22 to Minnesota residents who have served in any branch of the United States armed forces.
 1.23 Hunters may use bonus permits to take antlerless deer and may take a deer of either sex on

2.4 Subp. 4. **Open areas.** Wild turkey permit areas are open for the spring turkey season
2.5 as prescribed by the commissioner. Turkey licenses are valid for taking turkeys only in
2.6 the wild turkey permit area specified on the license, except for archery-only licenses
2.7 issued under Minnesota Statutes, section 97A.435, subdivision 5, paragraph (a), and
2.8 youth turkey licenses.

3.3 **6240.2300 COMMON CROW SEASON.**

3.4 Subpart 1. **Open dates.** Common crows may be taken from ~~July 15 through October~~
 3.5 ~~15 and from March 1 through March 31~~ January 1 to 15, March 1 to 31, September 1 to
 3.6 October 31, and December 15 to 31.

3.8 **REPEALER.** The expedited emergency amendments to Minnesota Rules, parts
 3.9 6230.0200, subpart 11, published in the State Register, volume 38, page 1145, February
 3.10 24, 2014, and 6240.2300, subpart 1, volume 39, page 260, August 25, 2014, are repealed.

3.11 **EFFECTIVE PERIOD.** The expedited emergency amendments to Minnesota Rules,
 3.12 parts 6232.2100 and 6236.0600, expire July 1, 2015. The expedited emergency
 3.13 amendments to Minnesota Rules, parts 6230.0200 and 6240.2300, expire May 1, 2016.
 3.14 Minnesota Rules, part 6236.1060, expires July 1, 2015.
