1.1 **Department of Natural Resources**1.2 **Adopted Expedited Emergency Game and Fish Rules: 2018 Bear Season**1.3 **6232.2800 GENERAL REGULATIONS FOR TAKING BEARS.**

1.4 Subpart 1. **Bag limit.** Except as provided in part 6232.3300, a person may not take  
1.5 more than one bear in quota areas and ~~two bears~~ one bear in no-quota areas during any  
1.6 calendar year whether by firearm or archery. Bears taken may be of either sex or any age  
1.7 except that bear cubs may not be taken.

1.9 **6232.3000 BEAR QUOTA AREAS.**

1.11 Subp. 6. **Bear Quota Area ~~26~~ 27.** Bear Quota Area ~~26~~ 27 consists of that portion of  
1.12 the state lying within the following described boundary:

1.13 Beginning at the junction of U.S. Highway 2 and State Trunk Highway (STH) 65;  
1.14 thence along STH 65 to STH 1; thence along STH 1 to STH 72; thence along STH 72  
1.15 to U.S. Highway 71; thence along U.S. Highway 71 to U.S. Highway 2; thence along  
1.16 U.S. Highway 2 to the point of beginning. County State-Aid Highway (CSAH) 46,  
1.17 Hubbard County; thence along CSAH 46 to CSAH 4, Beltrami County; thence along  
1.18 CSAH 4 to CSAH 25, Beltrami County; thence along CSAH 25 to CSAH 8, Beltrami  
1.19 County; thence along CSAH 8 to CSAH 27, Beltrami County; thence along CSAH 27  
1.20 to CSAH 12, Beltrami County; thence along CSAH 12 to CSAH 27, Beltrami County;  
1.21 thence along CSAH 27 to CSAH 20, Beltrami County; thence along CSAH 20 to CSAH  
1.22 39, Beltrami County; thence along CSAH 39 to the intersection of the north boundary  
1.23 of the Leech Lake Indian Reservation; thence along the north and east boundaries of  
1.24 the Leech Lake Indian Reservation to STH 6; thence along STH 6 to U.S. Highway 2;  
1.25 thence along U.S. Highway 2 to the point of beginning.

1.26 Subp. 6a. **Bear Quota Area 28.** Bear Quota Area 28 consists of that portion of the  
1.27 state lying within the following described boundary:

1.28 Beginning at the junction of U.S. Highway 2 and State Trunk Highway (STH) 6; thence  
1.29 along STH 6 to the east boundary of the Leech Lake Indian Reservation; thence along  
1.30 the east and north boundaries of the Leech Lake Indian Reservation to the intersection

2.1 of the north boundary of the Leech Lake Indian Reservation and County State-Aid  
 2.2 Highway (CSAH) 39, Beltrami County; thence along CSAH 39 to CSAH 20, Beltrami  
 2.3 County; thence along CSAH 20 to CSAH 27, Beltrami County; thence along CSAH  
 2.4 27 to CSAH 12, Beltrami County; thence along CSAH 12 to CSAH 27, Beltrami  
 2.5 County; thence along CSAH 27 to CSAH 8, Beltrami County; thence along CSAH 8  
 2.6 to CSAH 25, Beltrami County; thence along CSAH 25 to CSAH 4, Beltrami County;  
 2.7 thence along CSAH 4 to CSAH 46, Hubbard County; thence along CSAH 46 to U.S.  
 2.8 Highway 2; thence along U.S. Highway 2 to the point of beginning.

2.10 Subp. 9. **Bear Quota Area ~~43~~ 46.** Bear Quota Area ~~43~~ 46 consists of that portion of  
 2.11 the state lying within the following described boundary:

2.12 Beginning at the junction of U.S. Highway 59 and the northern boundary of the White  
 2.13 Earth Indian Reservation; thence along said boundary to State Trunk Highway (STH)  
 2.14 92; thence along STH 92 to U.S. Highway 2; thence along U.S. Highway 2 to ~~STH 6;~~  
 2.15 ~~thence along STH 6 to STH 18; thence along STH 18 to U.S. Highway 169; thence~~  
 2.16 ~~along U.S. Highway 169 to STH 23; thence along STH 23 to the Mississippi River;~~  
 2.17 ~~thence upstream along the easterly shore of said river to STH 27 at Little Falls; thence~~  
 2.18 ~~along STH 27 to U.S. Highway 71; thence along U.S. Highway 71 to U.S. Highway~~  
 2.19 ~~10; thence along U.S. Highway 10 to U.S. Highway 59; thence along U.S. Highway~~  
 2.20 ~~59 to the point of beginning.~~ County State-Aid Highway (CSAH) 45, Hubbard County;  
 2.21 thence along CSAH 45 to CSAH 9, Hubbard County; thence along CSAH 9 to CSAH  
 2.22 69, Cass County; thence along CSAH 69 to CSAH 5, Hubbard County; thence along  
 2.23 CSAH 5 to CSAH 39, Hubbard County; thence along CSAH 39 to County Road (CR)  
 2.24 94, Hubbard County; thence along CR 94 to CSAH 31, Hubbard County; thence along  
 2.25 CSAH 31 to STH 200; thence along STH 200 to U.S. Highway 371; thence along U.S.  
 2.26 Highway 371 to the south boundary of the Leech Lake Indian Reservation; thence  
 2.27 along the south and east boundaries of the reservation to the White Oak public access  
 2.28 road; thence along the public access road to STH 6; thence along STH 6 to CSAH 1,  
 2.29 Crow Wing County; thence along CSAH 1 to CSAH 2, Cass County; thence along  
 2.30 CSAH 2 to STH 371; thence along STH 371 to STH 87; thence along STH 87 to U.S.  
 2.31 Highway 10; thence along U.S. Highway 10 to U.S. Highway 59; thence along U.S.  
 2.32 Highway 59 to the point of beginning.

2.33 The Tamarac National Wildlife Refuge within Area ~~43~~ 46 is not open for bear hunting.

3.1 Subp. 9c. **Bear Quota Area 47.** Bear Quota Area 47 consists of that portion of the  
 3.2 state lying within the following described boundary:

3.3 Beginning at the junction of U.S. Highway 2 and County State-Aid Highway (CSAH)  
 3.4 45, Hubbard County; thence along CSAH 45 to CSAH 9, Hubbard County; thence  
 3.5 along CSAH 9 to CSAH 69, Cass County; thence along CSAH 69 to CSAH 5, Hubbard  
 3.6 County; thence along CSAH 5 to CSAH 39, Hubbard County; thence along CSAH 39  
 3.7 to County Road (CR) 94, Hubbard County; thence along CR 94 to CSAH 31, Hubbard  
 3.8 County; thence along CSAH 31 to State Trunk Highway (STH) 200; thence along STH  
 3.9 200 to U.S. Highway 371; thence along U.S. Highway 371 to the south boundary of  
 3.10 the Leech Lake Indian Reservation; thence along the south and east boundaries of the  
 3.11 reservation to the White Oak public access road; thence along the public access road  
 3.12 to U.S. Highway 2; thence along U.S. Highway 2 to the point of beginning.

3.14 **6232.3100 BEAR NO-QUOTA AREA.**

3.15 Licenses for the no-quota area are not limited in number and may be purchased at an  
 3.16 electronic licensing system (ELS) agent, ELS-Internet, or ELS-Telephone. A person may  
 3.17 purchase a license for both a quota area and the no-quota area in the same year. No-quota  
 3.18 licenses are valid only in the no-quota area: except when validated by a wildlife manager  
 3.19 or conservation officer for a nuisance bear in the quota area under part 6232.3300. When a  
 3.20 no-quota license is purchased after the start of the bear season, the license is valid only if  
 3.21 issued before legal shooting hours on the day the license is first used.

3.22 **6232.3200 BAIT STATIONS AND GARBAGE DUMPS.**

3.24 Subp. 2. **Registration of bait station.** A person may not establish a bear bait station  
 3.25 without registering the site as provided in this subpart.

3.26 A. The following information must be provided on a form provided by the  
 3.27 commissioner or on an 8-1/2 inch by 11 inch sheet of paper:

4.1 (1) name, address, Minnesota DNR number, and telephone number of person  
 4.2 who established the bear bait station; ~~and~~

4.3 (2) if being placed for someone else, name and Minnesota DNR number of  
 4.4 the person for whom the bait is established; and

4.5 ~~(2)~~ (3) county, township, range, and section in which the bear bait station is  
 4.6 established.

4.8 Subp. 3. **Display of sign.** A person establishing a bear bait station must display a sign  
 4.9 at the site meeting the following requirements.

4.11 B. The sign must contain:

4.12 (1) for unguided hunters, the full name and address and either the Minnesota  
 4.13 DNR number or the Minnesota driver's license number of both the person on whose behalf  
 4.14 the bait is placed and the person who is placing the bait; or

4.18 **6232.3300 NUISANCE BEARS.**

4.19 Nuisance bears may be taken under the conditions in this part by licensed bear hunters  
 4.20 ~~from July 1 to August 31 under the conditions in this part~~ or as authorized in item C.

4.21 A. Wildlife managers or conservation officers may authorize licensed hunters to  
 4.22 take nuisance bears after the manager or officer has verified that a nuisance problem exists.  
 4.23 To be eligible to take a nuisance bear, a licensed hunter must indicate interest as instructed

5.1 on the application form for the bear lottery. The commissioner must include hunters who  
5.2 indicate interest in a list of individuals eligible to take a nuisance bear. The list must include  
5.3 the hunters' names, addresses, telephone numbers, e-mail addresses, and Minnesota DNR  
5.4 numbers. The list must be used by wildlife managers and conservation officers when it is  
5.5 necessary to take a nuisance bear.

5.7 C. If no licensed hunter identified on the list under item A is available to take a  
5.8 nuisance bear, a hunter with a no-quota license may take a nuisance bear in the quota area  
5.9 if the hunter's license is validated by a wildlife manager or conservation officer. A no-quota  
5.10 license validated to take nuisance bears is valid for any area where a wildlife manager or  
5.11 conservation officer verifies that a nuisance-bear problem exists and is valid for taking  
5.12 nuisance bear during the time specified by the wildlife manager or conservation officer.

5.13 ~~E. D.~~ A licensee taking a nuisance bear prior to the season must register it with  
5.14 the authorizing wildlife manager or conservation officer within 48 hours after taking.

5.15 ~~D. A licensee who takes a nuisance bear may not take another bear in that year.~~

5.16 E. Nuisance bears taken under item C do not count toward a hunter's statewide  
5.17 bag limit of bear.

5.18 ~~E. F.~~ A licensee taking a nuisance bear is subject to all provisions of parts  
5.19 6232.2600 to 6232.3500 not inconsistent with this subpart and all laws relating to the taking  
5.20 of wild animals.

5.21 **REPEALER.** Minnesota Rules, part 6232.3000, subpart 9a, is repealed.

5.22 **EFFECTIVE PERIOD.** The expedited emergency amendments to Minnesota Rules, parts  
5.23 6232.2800, 6232.3000, 6232.3100, 6232.3200, and 6232.3300, expire December 31, 2018.  
5.24 After the emergency amendments expire, the permanent rules as they read before the  
5.25 amendments again take effect, except as they may be amended by permanent rule.
