1.2 **Adopted Expedited Emergency Game and Fish Rules: Taking Sharp-Tailed Grouse**  
1.3 **and Prairie Chickens**

1.4 **6234.0300 TAKING SHARP-TAILED GROUSE.**

1.5 *[For text of subps 1 and 2, see M.R.]*

1.6 Subp. 2a. **Northwest Zone.** The Northwest Zone for sharp-tailed grouse is that portion  
1.7 of the state's open area lying west of the following described boundary:

1.8 Beginning at the intersection of Voyageurs National Park and the north boundary of  
1.9 the state; thence along the west boundary of the park to the public access to Lake  
1.10 Kabetogama at Gappa's Landing; thence along County Road 523, St. Louis County, to  
1.11 County State-Aid Highway (CSAH) 123, St. Louis County; thence along CSAH 123  
1.12 to CSAH 122, St. Louis County; thence along CSAH 122 to United States Highway  
1.13 (U.S.) 53; thence along U.S. 53 to the intersection of U.S. 73 and State Trunk Highway  
1.14 1.

1.15 Subp. 2b. **East-Central Zone.** The East-Central Zone for sharp-tailed grouse is that  
1.16 portion of the state's open area that is not included in the Northwest Zone.

1.17 Subp. 3. **Open season.** Sharp-tailed grouse may be taken by firearm or bow and arrow  
1.18 from the Saturday on or nearest September 16 to November 30 in the Northwest Zone and  
1.19 from the Saturday on or nearest October 13 to November 30 in the East-Central Zone.

1.20 **6237.0400 TAKING PRAIRIE CHICKENS.**

1.21 Subpart 1. **Open season and methods.** Prairie chickens may be taken during the  
1.22 ~~five-day~~ ~~nine-day~~ period beginning on the last Saturday ~~nearest October 20~~ in September.

1.24 Subp. 4. **Open areas.** Prairie chicken permit areas are open for the prairie chicken  
1.25 season as prescribed by the commissioner. Prairie chicken licenses are valid only in the  
1.26 prairie chicken permit area specified on the license. The following prairie chicken permit

2.1 areas, as described in part 6237.0550, are open: 803A, 804A, 805A, 806A, 807A, 808A,  
2.2 809A, 810A, 811A, 812A, and 813A.

2.4 **6237.0550 PRAIRIE CHICKEN PERMIT AREA DESCRIPTION.**

2.6 Subp. 2. [See repealer.]

2.7 Subp. 3. **Area 803A.** Prairie chicken permit area 803A consists of that portion of the  
2.8 state lying within the following described boundary:

2.9 Beginning at the intersection of United States Highway (U.S.) 59 and State Trunk  
2.10 Highway (STH) 32; thence along U.S. 59 to U.S. 2; thence along U.S. 2 to STH 32;  
2.11 thence along STH 32 Pennington County State-Aid Highway (CSAH) 3; thence along  
2.12 U.S. 59 to U.S. 2; thence along U.S. 2 to U.S. 75; thence along U.S. 75 to Polk CSAH  
2.13 21; thence along Polk CSAH 21 to Pennington CSAH 3; thence along Pennington  
2.14 CSAH 3 to the point of beginning.

2.16 Subp. 12. **Area 812A.** Prairie chicken permit area 812A consists of that portion of  
2.17 the state lying within the following described boundary:

2.18 Beginning at the intersection of State Trunk Highway (STH) 32 and STH 113; thence  
2.19 along STH 113 to United States Highway (U.S.) 59; thence along U.S. 59 to U.S. 10;  
2.20 thence along U.S. 10 to STH 32; thence along STH 32 to the point of beginning.

2.21 Subp. 13. **Area 813A.** Prairie chicken permit area 813A consists of that portion of  
2.22 the state lying within the following described boundary:

2.23 Beginning at the intersection of State Trunk Highway (STH) 32 and Polk County  
2.24 State-Aid Highway (CSAH) 1; thence along CSAH 1 to United States Highway (U.S.)  
2.25 59; thence along U.S. 59 to STH 113; thence along STH 113 to STH 32; thence along  
2.26 STH 32 to the point of beginning.

2.27 **REPEALER.** Minnesota Rules, part 6237.0550, subpart 2, is repealed.

- 3.1 **EFFECTIVE PERIOD.** The expedited emergency amendments to Minnesota Rules, parts  
3.2 6234.0300, 6237.0400, and 6237.0550, expire December 31, 2018. After the expedited  
3.3 emergency amendments expire, the permanent rules as they read before those amendments  
3.4 again take effect, except as they may be amended by permanent rule.
