2.3	B. To participate in the hunt authorized in item A, hunters must purchase a disease
2.4	management permit according to part 6232.1980 or possess a 2018 Minnesota landowner
2.5	license, youth or adult firearm license, youth or adult muzzleloader license, youth or adult
2.6	archery license, or early-season antlerless license. During the hunt authorized in item A:
2.7	(1) hunters may tag deer of either sex with disease management tags or unused
