4.6 **Subp. 3. Lac qui Parle zones, Chippewa and Lac qui Parle Counties.**

4.7 **A.** On the Lac qui Parle Wildlife Management Area in Chippewa and Lac qui  
 4.8 Parle Counties, the controlled hunting zone includes the following:

4.9 The Northwest Quarter of the Southwest Quarter (NW 1/4 SW 1/4) and the Southeast  
 4.10 Quarter of the Southwest Quarter (SE 1/4 SW 1/4) of Section 32, Township 119 North,  
 4.11 Range 42 West, and the Northwest Quarter of the Northeast Quarter (NW 1/4 NE 1/4)  
 4.12 and the East Half of the Northwest Quarter (E 1/2 NW 1/4) of Section 5, Township  
 4.13 118 North, Range 42 West, all in Lac qui Parle County.

4.14 And also the East Half of the Northwest Quarter (E 1/2 NW 1/4), the East Half of the  
 4.15 Southwest Quarter (E 1/2 SW 1/4) and the West Half of the West Half of the Southeast  
 4.16 Quarter (W 1/2 W 1/2 SE 1/4) of Section 12, Township 118 North, Range 42 West,

5.14 Subp. 4. **Open season and hours for migratory game birds.** Woodcock, sora and  
 5.15 Virginia rails, mourning dove, and common snipe may be taken by falconry from September  
 5.16 1 to December 16. Ducks, coots, and moorhens (Gallinules) may be taken by falconry ~~from~~  
 5.17 ~~the Saturday nearest October 1 to the Saturday nearest January 14~~ during the open seasons  
 5.18 prescribed in part 6240.0640, subpart 1, and statewide from December 14 through January  
 5.19 27, 2020. Geese may be taken by falconry during any open goose season. Crows may be  
 5.20 taken by falconry during the open season. Falconry hours are from one-half hour before  
 5.21 sunrise to sunset, except during the regular waterfowl season when falconry hours are the  
 5.22 same as waterfowl shooting hours.

6.1 Subp. 1a. **Early goose season.** "Early goose season" means goose seasons ~~beginning~~  
6.2 ~~before~~ open September ~~16~~ 1 through September 15.

6.4 **6240.0200 GENERAL RESTRICTIONS FOR TAKING AND POSSESSION OF**  
6.5 **MIGRATORY GAME BIRDS.**

6.6 Subpart 1. **Shooting hours.** Shooting hours for migratory waterfowl, coots, gallinules,  
6.7 rails, and snipe are one-half hour before sunrise to sunset, except ~~as follows:~~

6.8 ~~A. on the opening day of the duck season, shooting hours begin at 9:00 a.m.; and~~

6.9 ~~B. from the opening day of the duck season to the Saturday nearest~~ through October  
6.10 & 4, shooting hours end at 4:00 p.m.

6.11 Subp. 2. **Possession limits.** The possession limit is ~~twice~~ three times the daily limit,  
6.12 except for rails where the daily and possession limits are the same. All restrictions specific  
6.13 to a species or gender apply.

6.15 Subp. 4. **Use of motorized watercraft.** A person may use motorized watercraft in  
6.16 the waterfowl feeding and resting area established on South Heron Lake during the early  
6.17 goose season established in part 6240.1200.

6.19 Subp. 7. **Taking in open water.** A person may take migratory waterfowl, coots,  
6.20 gallinules, rails, and snipe in open water on the following waters of Minnesota with the  
6.21 restrictions given:

6.22 A. the area of the Mississippi River and backwaters within the boundary beginning  
6.23 at the intersection of U.S. Highway 61 and the Minnesota boundary in Dakota County;  
6.24 thence along U.S. Highway 61 to U.S. Highway 63; thence along U.S. Highway 61/63 to

7.1 U.S. Highway 61; thence along U.S. Highway 61 to U.S. Highway 14; thence along U.S.  
7.2 Highway 61/14 to Interstate 90; thence along Interstate 90/U.S. Highway 61/14 to State  
7.3 Trunk Highway (STH) 16; thence along STH 16 to STH 26; thence along STH 26 to the  
7.4 state's southern boundary; thence along the southern boundary to the eastern boundary;  
7.5 thence along the eastern boundary to the point of the beginning: hunting is allowed not more  
7.6 than 100 feet from any shoreline, including islands, from boats that must be at anchor;

7.7 B. Lake Pepin, Lake of the Woods, and Lake Mille Lacs: hunting is allowed from  
7.8 boats that must be at anchor; and

7.9 C. Lake Superior north and east of the Minnesota Park Point peninsula: hunting  
7.10 is allowed from boats that must be at anchor.

7.11 **6240.0250 TAKING MOURNING DOVES.**

7.12 Subpart 1. **Open season.** Mourning doves may be taken during the ~~60-day~~ 90-day  
7.13 period beginning September 1.

7.15 **6240.0610 YOUTH WATERFOWL HUNTING ~~DAY~~ WEEKEND.**

7.16 Subpart 1. **Dates, eligibility, and license requirements.** Ducks, mergansers, coots,  
7.17 moorhens, and ~~Canada~~ dark or light geese may be taken statewide on Youth Waterfowl  
7.18 Hunting ~~Day~~ Weekend, September 7 and 8, by resident and nonresident hunters ~~15~~ 17 years  
7.19 of age or younger. An adult resident or nonresident mentor 18 years of age or older, who  
7.20 is authorized by the youth's parent or guardian, must accompany the youth hunter at all  
7.21 times during the hunt. The accompanying adult may not hunt. No hunting license or state  
7.22 waterfowl stamps are required, except all youths age 16 and older are required to have a  
7.23 federal migratory bird stamp.

7.24 Subp. 2. **Shooting hours.** Shooting hours are one-half hour before sunrise to ~~4:00~~  
7.25 ~~p.m.~~ sunset.



8.1 Subp. 3. **Bag limits.** The daily bag limit for ducks, mergansers, coots, and moorhens  
8.2 is as allowed by federal rule. The daily bag limit for geese is five ~~Canada~~ dark geese and  
8.3 20 light geese.

8.4 **6240.0630 TAKING SANDHILL CRANE.**

8.5 Subpart 1. **Open season.** Sandhill cranes may be taken from September 14 through  
8.6 October 20.

8.7 Subp. 2. **Shooting hours.** Shooting hours for sandhill cranes are one-half hour before  
8.8 sunrise to sunset, except beginning on the opening day of duck season, shooting hours are  
8.9 the same as shooting hours for the duck season as described in part 6240.0200, subpart 1.

8.10 Subp. 3. **Open area; taking restrictions.**

8.11 A. Sandhill cranes may be taken only in the Northwest Goose Zone as described  
8.12 in part 6240.0860, subpart 1.

8.13 B. Taking sandhill cranes is prohibited on or within 100 yards of all surface waters.

8.14 C. Sandhill cranes may be taken by bow and arrow or shotgun with nontoxic shot  
8.15 approved by the United States Fish and Wildlife Service. A person may not take sandhill  
8.16 cranes with a rifle or handgun.

8.17 Subp. 4. **License and permit requirements.**

8.18 A. Sandhill cranes may only be taken with:

8.19 (1) a valid permit to take sandhill cranes issued by the commissioner for a  
8.20 fee of \$3; and

8.21 (2) a small-game license, unless exempted.

8.22 B. A hunter must have a permit to take sandhill cranes in possession when taking  
8.23 or possessing sandhill cranes.

9.1 C. A hunter must not have had small- or big-game hunting privileges revoked  
9.2 within one year of purchasing a permit to take sandhill cranes.

9.3 Subp. 5. **Bag and possession limits.** A person may not take more than one sandhill  
9.4 crane per day or have more than three sandhill cranes in possession.

9.5 Subp. 6. **Game and waterfowl refuges.** All state game refuges closed to  
9.6 migratory-waterfowl hunting are closed to taking sandhill cranes under this part. All  
9.7 waterfowl refuges closed by posting to taking ducks or geese during any portion of the fall  
9.8 waterfowl seasons are closed to taking sandhill cranes under this part.

9.9 Subp. 7. **Penalties.** Violating this part or the conditions of any permit issued under  
9.10 this part results in revocation of the permit and any other penalty provided by state or federal  
9.11 law.

9.12 **6240.0640 TAKING COOTS, MOORHENS, AND DUCKS.**

9.13 Subpart 1. **Open seasons.** Coots, moorhens, ducks, and mergansers may be taken as  
9.14 follows:

9.15 A. in the North Waterfowl Zone, as described in part 6240.0620, subpart 2, during  
9.16 the 60-day period from September 21 through November 19;

9.17 B. in the Central Waterfowl Zone, as described in part 6240.0620, subpart 4,  
9.18 during the 60-day period that includes September 21 through September 29 and October 5  
9.19 through November 24; and

9.20 C. in the remainder of the state, during the 60-day period that includes September  
9.21 21 through September 29 and October 12 through December 1.

9.22 Subp. 2. **Daily limits.** In any one day, a person may not take more than six ducks,  
9.23 five mergansers, and a total of 15 coots and moorhens. The daily limit of ducks, other than  
9.24 mergansers, may not include more than four mallards, including two female mallards; one

10.1 pintail; two redheads; three scaup; three wood ducks; two black ducks; and two canvasback.

10.2 The daily limit of mergansers may not include more than two hooded mergansers.

10.3 **6240.0950 TAKING GEESE.**

10.4 Subpart 1. **Open seasons.** Geese may be taken as follows:

10.5 A. statewide during the early goose season, for which a special-season goose  
10.6 license is required under Minnesota Statutes, section 97B.802;

10.7 B. in the North Waterfowl Zone, as described in part 6240.0620, subpart 2,  
10.8 September 21 through December 21;

10.9 C. in the Central Waterfowl Zone, as described in part 6240.0620, subpart 4,  
10.10 September 21 through September 29 and October 5 through December 26; and

10.11 D. in the South Waterfowl Zone, as described in part 6240.0620, subpart 3,  
10.12 September 21 through September 29 and October 12 through January 2, 2020.

10.13 Subp. 2. **Daily limits.** From September 1 through September 15, the bag limit for dark  
10.14 geese is five combined and the bag limit for light geese is 20 combined. After September  
10.15 15, a person may not take more than three dark geese or 20 light geese statewide. Dark  
10.16 geese are Canada, brant, and white-fronted geese. Light geese are snow, blue, and Ross's  
10.17 geese.

10.18 Subp. 3. **Taking near water.**

10.19 A. Taking geese during the early goose season is prohibited on or within 100  
10.20 yards of all surface waters:

10.21 (1) in the Northwest Goose Zone, as described in part 6240.0860;

10.22 (2) in the Swan Lake Goose Zone, as described in part 6240.0860; and

10.23 (3) within the boundaries of the Carlos Avery Wildlife Management Area.

11.1 B. Taking geese on or within 100 yards of surface waters during the early goose  
 11.2 season is allowed for youth hunters participating in youth waterfowl hunting days and on  
 11.3 specific bodies of water in closed zones as described or shown on maps provided by the  
 11.4 commissioner.

11.5 **6240.1850 REFUGES OPEN TO TAKING GEESE.**

11.7 Subp. 2. **Game refuges.**

11.8 ~~A. The following refuges are open to goose hunting during the first two days of~~  
 11.9 ~~the regular goose season: Fox Lake Game Refuge in Martin County and The Saint James~~  
 11.10 ~~Game Refuge in Watonwan County~~ is open to goose hunting during the first two days of  
 11.11 the regular goose season.

11.12 ~~B. The Fox Lake Game Refuge is open to goose hunting for the last seven days~~  
 11.13 ~~of the statewide goose season. There is no goose hunting within 100 yards of Fox and~~  
 11.14 ~~Temperence Lakes.~~

11.16 **6240.2000 MIGRATORY WATERFOWL FEEDING AND RESTING AREA**  
 11.17 **RESTRICTIONS.**

11.19 Subp. 4. **Use of electric motors.** On the lakes listed in items A to ~~J~~K, a person may  
 11.20 use an electric motor with battery power of 12 volts or less within the designated migratory  
 11.21 waterfowl feeding and resting area during the open waterfowl season:

11.23 F. Kandiyohi County: ~~Wagona~~ Lake Wakanda, Lake Lillian;

12.1 I. Pope County: Nelson Lake; ~~and~~

12.2 J. Traverse County: Mud Lake; and

12.3 K. Le Sueur County: Diamond Lake, Dora Lake, Sanborn Lake.

12.4 **REPEALER.** Minnesota Rules, parts 6230.0400, subpart 54; 6230.0700, subparts 3 and  
12.5 6; 6240.1150, subpart 2; 6240.1200, subparts 3, 4, and 5; and 6240.1800, subpart 1, are  
12.6 repealed.

12.7 **EFFECTIVE PERIOD.** The emergency amendments to Minnesota Rules, parts 6230.0100,  
12.8 6230.0400, 6230.0600, 6230.0700, 6234.0800, 6240.0100, 6240.0200, 6240.0250, 6240.0610,  
12.9 6240.1150, 6240.1200, 6240.1800, 6240.1850, and 6240.2000, expire January 30, 2020.

12.10 After the emergency amendments expire, the permanent rules as they read before those  
12.11 amendments again take effect, except as they may be amended by permanent rule. Minnesota  
12.12 Rules, parts 6240.0630, 6240.0640, and 6240.0950, expire January 30, 2020.
