3.15 Subpart 1. ~~Spring license application drawings~~ Special turkey hunts.

3.16 A. Applications ~~for spring hunts~~ to hunt the Mille Lacs, Carlos Avery, or
 3.17 Whitewater Wildlife Management Areas must be made according to this part and according
 3.18 to application instructions provided by the commissioner. Each person must apply at an
 3.19 electronic license system agent or the Department of Natural Resources License Center.
 3.20 Drawings will be conducted by the department to determine persons who will be eligible
 3.21 ~~to purchase licenses for each season~~ hunt in the specified wildlife management areas during
 3.22 periods A to C. The drawings will be subject to the quotas established by the commissioner.
 3.23 Preference in the respective drawings is given to applicants based upon the number of times
 3.24 they have correctly applied ~~for a license for that~~ to hunt one of the specified wildlife

4.1 ~~management areas but have been unsuccessful. A person selected by the drawings is~~
4.2 Successful applicants are eligible to purchase a license to hunt turkey in the wildlife
4.3 management area they selected during the period indicated on their turkey-hunting license.
4.4 Successful applicants may also hunt in areas that are otherwise open to spring turkey hunting.
4.5 Upon issuance of a turkey license for the spring season permit to hunt one of the specified
4.6 wildlife management areas, all accumulated preference for that season is lost, except as
4.7 provided in subpart 6.

4.8 B. No lottery application is needed to purchase a spring or fall turkey license.

4.9 C. Only successful applicants will be notified.

4.10 Subp. 2. **Participation in application drawings.** A person may not apply more than
4.11 once for a hunt, whether as an individual or as a member of a group. ~~Qualifying individuals~~
4.12 ~~may apply for the resident landowner-tenant turkey drawing.~~ All of the information in items
4.13 A to ~~G~~ F must be supplied on the application forms.

4.16 Group applications shall either all be selected or none selected. All group members must
4.17 apply for the same wild turkey permit ~~areas and time periods~~ area and period. The preference
4.18 rating of applicants who apply as a group ~~shall be~~ is determined by the individual in the
4.19 group with the lowest preference. ~~Group applications may be made up of all general or all~~
4.20 ~~landowner-tenant applications, but not both.~~

4.21 ~~D. A person who applies as a landowner or tenant but does not meet the definition~~
4.22 ~~as provided by this part will be ineligible for that season's drawings.~~

4.23 ~~E.~~ D. The application deadline ~~for the spring season~~ is the second Friday in January
4.24 February.

5.1 ~~F. E. Youth age 17 and younger may purchase a wild turkey hunting license to~~
5.2 ~~hunt all eight spring turkey time periods. A wild turkey hunting license under this item is~~
5.3 ~~separate from the normal lottery process and is valid for hunting in any wild turkey permit~~
5.4 ~~area.~~

5.5 ~~G. F. A person who has not applied for a wild turkey license through the lottery~~
5.6 ~~or who applied for a license and was unsuccessful in the lottery may purchase a wild turkey~~
5.7 ~~hunting license to hunt the spring turkey season during the fourth, fifth, sixth, seventh, or~~
5.8 ~~eighth time period. A wild turkey hunting license under this item is separate from the normal~~
5.9 ~~lottery process. Firearms hunters who purchase a license under this item age 18 and older~~
5.10 ~~must choose and hunt in one time period. Archery Archery-only hunters who purchase a~~
5.11 ~~license under this item may hunt throughout the fourth, fifth, sixth, seventh, and eighth time~~
5.12 ~~all periods. A hunter who has an unfilled tag may also hunt during the sixth period.~~

5.13 ~~(1) Turkey lottery preference points shall not be reduced for a person~~
5.14 ~~purchasing a license under this item.~~

5.15 ~~(2) A person may take only one bearded turkey during the entire spring turkey~~
5.16 ~~season regardless of whether the hunter purchased a license through the lottery system or~~
5.17 ~~as provided in this item.~~

6.5 ~~C. A person may purchase a fall or spring turkey license without an application.~~
 6.6 ~~A turkey permit area must be selected, but hunters are not required to hunt in that area.~~

 6.9 15 and consists of ~~six~~ five consecutive ~~five-day~~ seven-day periods followed by ~~two~~
 6.10 ~~consecutive seven-day periods~~ one final period that ends May 31.
