1.5 **6230.0200 SPECIAL PROVISIONS FOR WILDLIFE MANAGEMENT AREAS.**

1.7 **Subp. 5. Areas closed to hunting and trapping.**

1.8 A. The following wildlife management areas are closed to hunting and trapping  
1.9 all species:

1.10 (1) Boerner Wildlife Management Area in Sibley County,~~the~~;

1.11 (2) Buelow Wildlife Management Area in Steele County,~~the~~;

1.12 (3) Bryson Wildlife Management Area in Freeborn County,~~the~~;

1.13 (4) Chapa-Kak-Say-Za Wildlife Management Area in Steele County;~~;~~ and

1.14 ~~the~~

1.15 (5) Hutchinson Wildlife Management Area in McLeod County ~~are closed to~~  
1.16 ~~the hunting and trapping of all species.~~

1.17 B. The Sand Prairie Wildlife Management Area in Sherburne County is closed to  
1.18 ~~the hunting and trapping of~~ all species, except for:

1.19 (1) hunting by individuals with disabilities participating in a special hunt;

1.20 (2) youth ages ten to 17 who are participating in the regular archery season.

1.21 Youth may take one deer under this subitem but may not hunt during events for individuals  
1.22 with disabilities; and

1.23 (3) youth up to age 17 during the spring turkey season.

2.9 G. Hampton Woods Wildlife Management Area in Dakota County is open as

2.12 (2) hunting turkey during the spring and fall turkey seasons;

2.13 (3) trapping by special permit only;

2.14 (4) hunting predators by special permit only; and

2.15 (5) hunting small game through November 30.

2.16 Subp. 12. **Sanctuary areas open to hunting.** The following sanctuary areas of wildlife  
2.17 management areas posted with "Wildlife Sanctuary Do Not Trespass" signs are open ~~for~~

3.4 which there is an open season.

3.7 Subpart 1. **Hunting.** The Vermillion Highlands Wildlife Management Area located  
3.8 in Dakota County is closed to all hunting and trapping except:

3.16 Subp. 2. **Bemidji Game Refuge, Beltrami County.** The Bemidji Game Refuge in  
3.17 Beltrami County is open to:

3.18 A. small game hunting, except waterfowl, through the Thursday nearest November  
3.19 4 and after ~~the close of the 200 Series firearms deer season~~ November 21;

4.1 Subp. 5. **Clay County Game Refuge, Clay County.** The Clay County Game Refuge

4.4 duck season;

4.10 Subp. 21. **Lac qui Parle Game Refuge, Chippewa and Lac qui Parle Counties.** The

5.5 deer and bear hunting during the established seasons, by written permission of the landowner.

5.7 Subp. 61. **St. Cloud Game Refuge, Stearns County.** The St. Cloud Game Refuge

5.10 Refuge in Beltrami County is open to:

5.11 A. small-game hunting, except waterfowl, beginning November 1 through the  
5.12 end of the respective seasons;

5.13 B. trapping beginning November 1 through the end of the respective seasons;

5.14 C. deer and bear hunting by archery; and

5.15 D. deer hunting by firearms.

5.16 Subp. 63. **Butterball and Little Rice Game Refuges, St. Louis County.** The  
5.17 Butterball and Little Rice Game Refuges in St. Louis County are open November 25 through  
5.18 May 15 for trapping any species for which there is an open season.

5.19 **6234.0600 TAKING JACK RABBITS, COTTONTAIL RABBITS, AND SNOWSHOE**  
5.20 **HARES.**

5.22 Subp. 2. **Bag limits.** A person may not take more than ten cottontail rabbits, ~~jack~~  
5.23 ~~rabb~~its, and snowshoe hares, combined, per day or possess more than 20 cottontail rabbits,

6.1 ~~jack rabbits,~~ and snowshoe hares, combined, at a time. A person may not take more than  
6.2 one jack rabbit per day or possess more than three jack rabbits, combined, at a time.

6.3 **6234.1400 TAKING WEASELS, BADGER, AND OPOSSUM.**

6.4 Subpart 1. **Open season.** Long-tailed weasels, short-tailed weasels, badgers, and  
6.5 opossums may be taken statewide ~~with~~ by legal firearms, bow and arrow, and ~~by~~ trapping  
6.6 from 9:00 a.m. on the Saturday nearest October 22, except in the North  
6.7 Mink/Muskrat/Beaver/Otter Zone as described in part 6234.1000, subpart 3, where ~~badger~~  
6.8 ~~and opossum~~ long-tailed weasels, short-tailed weasels, badgers, and opossums may be taken  
6.9 ~~with~~ by legal firearms, bow and arrow, and ~~by~~ trapping beginning at 9:00 a.m. on the  
6.10 Saturday nearest October 17. The season ends March 15.

6.12 **6234.1600 TAKING BOBCAT.**

6.13 Subpart 1. **Open season.** Bobcats may be taken with legal firearms, bow and arrow,  
6.14 and ~~by~~ trapping from ~~the first Saturday following Thanksgiving,~~ December 18, to ~~the Sunday~~  
6.15 ~~nearest,~~ January ~~6~~ 23.

6.17 **6234.1700 TAKING FISHER AND PINE MARTEN.**

6.18 Subpart 1. **Open season.** Fisher and pine marten may be taken by trapping from ~~the~~  
6.19 ~~first Saturday following Thanksgiving,~~ December 18, to ~~the Sunday nearest,~~ December ~~12~~  
6.20 26.

6.21 Subp. 2. **Bag limits.** The combined limit for fisher and pine marten is ~~five~~ two per  
6.22 season, in aggregate. A person may not take more than ~~five~~ two fisher and pine marten,  
6.23 combined, per season or possess more than ~~five~~ two fisher and pine marten, combined, at  
6.24 a time, except that a person may possess additional pelts that the person lawfully took,  
6.25 tagged, and registered during previous seasons.

7.2 **6234.2000 TAKING OTTER.**

7.3 Subpart 1. **Open season for otter in North Zone.** Otter may be taken by trapping  
7.4 from 9:00 a.m. on the Saturday nearest October 26 to the Sunday nearest, January 6 23,  
7.5 only in that portion of the state described in part 6234.1000, subpart 3.

7.6 Subp. 2. **Open season and area for otter in South Zone.** Otter may be taken by  
7.7 trapping from 9:00 a.m. on the Saturday nearest October 30 to the Sunday nearest, January  
7.8 6 23, in the remainder of the state described in part 6234.1000, subpart 4.

7.10 **6236.0700 FALL TURKEY SEASON.**

7.12 Subp. 4. **Open areas.** Wild turkey permit areas are open for the fall turkey season as  
7.13 prescribed by the commissioner. Turkey licenses are valid ~~for taking turkeys only in the~~  
7.14 ~~wild turkey permit area specified on the license~~ statewide. The following wild turkey permit  
7.15 areas are open for the 2021 fall season: 501, 502, 503, 504, 505, 506, 507, 508, 509, 510,  
7.16 511, and 512.

7.18 **6240.1955 MIDDLE RIVER GOOSE HUNT FOR VETERANS.**

7.19 Disabled military veterans may hunt geese within 100 yards of water in the Northwest  
7.20 Goose Zone described in part 6240.0860 when participating in a special hunt sponsored by  
7.21 Middle River Veterans Outdoors. The special hunt will be held September 18 and 19 in  
7.22 Marshall County. Participants must meet all requirements of the sponsoring organization  
7.23 and must possess any required licenses before the hunt.

8.1 **REPEALER.** Minnesota Rules, part 6230.0295, subpart 2, is repealed. The emergency  
8.2 amendments to Minnesota Rules, parts 6230.0200; 6230.0295; 6230.0400; 6234.0600; and  
8.3 6234.1400, published in the State Register, volume 45, page 34, July 6, 2020, are repealed.

8.4 **EFFECTIVE PERIOD.** The emergency amendments to Minnesota Rules, parts 6230.0200,  
8.5 6230.0295, 6230.0400, 6234.0600, and 6234.1400, expire August 15, 2022. The emergency  
8.6 amendments to Minnesota Rules, parts 6234.1600, 6234.1700, 6234.2000, and 6236.0700,  
8.7 expire February 28, 2022. After the emergency amendments expire, the permanent rules  
8.8 again take effect, subject to any permanent rule amendments that have been adopted in the  
8.9 interim. Minnesota Rules, part 6240.1955, expires February 28, 2022.
