6240.0610 YOUTH WATERFOWL HUNTING DAY.

Subpart 1. **Dates, eligibility, and license requirements.** Ducks, mergansers, coots, moorhens, and Canada dark or light geese may be taken statewide on Youth Waterfowl Hunting Day Weekend, September 10 and 11, by resident and nonresident hunters 15 17 years of age or younger. An adult resident or nonresident mentor 18 years of age or older, who is authorized by the youth's parent or guardian, must accompany the youth hunter at all times during the hunt. The accompanying adult may not hunt. No hunting license or state waterfowl stamps are required, except all youth hunters age 16 and older must have a federal migratory bird stamp.
