Department of Natural Resources 1.1 Adopted Expedited Emergency Game and Fish Rules: Light Goose Population Control 1.2 6240.0600 SPECIAL LICENSES FOR LIGHT GOOSE POPULATION CONTROL. 1.3 Subpart 1. **Definition.** For purposes of this part, "light goose" means a lesser snow 1.4 goose including a blue phase lesser snow goose (Anser c. caerulescens) or a Ross's goose 1.5 (Anser rossii). 1.6 Subp. 2. License required. A person may not take a light goose during the period 1.7 prescribed in subpart 3 except under a valid license and in full compliance with this part 1.8 and the conditions in the license. Residents and nonresidents may apply for licenses. No 1.9 other hunting license or stamps are required. A license holder must have a license in 1.10 possession at all times when taking or transporting light geese taken under this part and 1.11 must retain the license for as long as the license holder possesses light geese taken under 1.12 1.13 this part. Subp. 3. Open harvest period. Light geese may be taken from February 18 to April 1.14 1.15 30 with licenses issued under this part. Shooting hours are one-half hour before sunrise to 1.16 one-half hour after sunset. Subp. 4. Bag limits. No daily or bag limits apply to taking light geese under this part. 1.17 Subp. 5. Game refuges and waterfowl refuges. All state refuges closed to migratory 1.18

1.19 waterfowl hunting are closed to taking light geese under this part. All waterfowl refuges closed by posting to taking ducks or geese during any portion of the fall waterfowl seasons 1.20 are closed to taking light geese under this part. All controlled hunting stations in the Lac 1.21 1.22 qui Parle Game Refuge, Chippewa and Lac qui Parle Counties, are closed to taking light geese under this part. 1.23

2.1	Subp. 6. License conditions; applicability of other laws and rules.
2.2	A. A license issued under this part is effective on the date issued or February 18,
2.3	whichever occurs later. A license expires April 30 of the year it is issued.
2.4	B. Except as provided in subparts 2 to 5, all applicable provisions of state statutes
2.5	and federal law for taking migratory waterfowl apply to taking light geese under this part.
2.6	All applicable rules for taking migratory waterfowl apply to taking light geese under this
2.7	part, unless inconsistent with or otherwise provided in this part.
2.8	C. By July 1, licensees must submit records of their light goose harvest to the
2.9	Department of Natural Resources on forms provided by the commissioner.
2.10	Subp. 7. License application. Application for a license under this part must be made
2.11	using the application processes established by the commissioner under Minnesota Statutes,
2.12	section 84.027, subdivision 15.
2.13	Subp. 8. Penalties. Violation of this part or the conditions of any license issued under
2.14	this part results in revocation of the license, and any other penalties provided by state or
2.15	federal law apply.
2.16	Subp. 9. License eligibility. To be eligible for a light goose license, a person must
2.17	not have any small game hunting privileges revoked within one year before purchasing a
