1.2 **Adopted Expedited Emergency Game and Fish Rules: Daily and Possession Limits**

1.4 **6262.0200 FISHING REGULATIONS FOR INLAND WATERS.**

1.5 Subpart 1. **General inland fishing regulations.** Fish may be taken in inland waters
1.6 by angling during the time specified for each of the following species; however, certain
1.7 waters of the state are subject to experimental or special regulations or are closed for taking
1.8 and possessing fish. When the closing date of a season falls on a Saturday, the season extends
1.9 through the following Sunday.

1.22 following applies to the species, seasons, and limits for taking fish on Minnesota-Iowa
1.23 boundary waters:

 2.12 Minnesota-Iowa boundary waters, except that carp, buffalo, sheepshead, bowfin, gar, and
 2.13 quillback may be taken by spearing ~~and possessed without limit.~~ The possession limit for
 2.14 all gar is ten in aggregate. For all other species listed in this subpart, there is no possession
 2.15 limit.

3.7 Subp. 3. **Spearing restrictions.** The taking of fish by spearing is prohibited on
 3.8 Minnesota-North Dakota boundary waters, except that carp, buffalo, sheepshead, suckers,
 3.9 redhorse, bowfin, and gar may be taken by spearing from May 1 through December 31
 3.10 between sunrise and sunset each day. ~~There is no possession limit on the listed species of~~
 3.11 ~~fish.~~ The possession limit for longnose and shortnose gar is ten in aggregate. For all other
 3.12 species listed in this subpart, there is no possession limit. A person may not have in
 3.13 possession on or near the water or ice of Minnesota-North Dakota boundary waters a spear
 3.14 at any time, except during the open season for spearing. Possession includes personal
 3.15 possession and possession in a vehicle.

3.17 Subp. 8. **Dark house spearing.** Taking fish by spearing from or within a dark house
 3.18 is allowed on Minnesota-North Dakota boundary waters according to items A to ~~E~~ F.

3.20 B. Carp, buffalo, sheepshead, suckers, redhorse, and bowfin, ~~and~~ ~~gar~~ may be taken
 3.21 with a spear and possessed without limit.

3.22 C. Longnose and shortnose gar may be taken with a spear. The possession limit
 3.23 for all gar is ten in aggregate.

3.24 ~~E~~. D. Northern pike may be taken with a spear and the possession limit is three.

4.1 ~~D.~~ E. A person may not have a spear in possession on or near the water or ice of
 4.2 Minnesota-North Dakota boundary waters at any time, except during the open season for
 4.3 spearing.

4.4 ~~E.~~ F. Possession includes personal possession and possession in a vehicle.

4.21 When the closing falls on a Saturday, the season extends through the following Sunday.

4.22 Subp. 3. **Spearing restrictions.** The taking of fish by spearing is prohibited on
 4.23 Minnesota-South Dakota boundary waters, except that carp, buffalo, sheepshead, suckers,
 4.24 redhorse, bowfin, and burbot, and gar may be taken by spearing and possessed without limit
 4.25 from May 1 through the last day in February between sunrise and sunset each day. Longnose
 4.26 and shortnose gar may be taken by spearing from May 1 through the last day in February
 4.27 between sunrise and sunset each day. The possession limit for all gar is ten in aggregate.

5.1 When the closing day falls on a Saturday, the season extends through March 1. A person
 5.2 may not have a spear in possession on or near the water or ice of Minnesota-South Dakota
 5.3 boundary waters at any time, except during the open season for spearing. Possession includes
 5.4 personal possession and possession in a vehicle.

5.6 Subp. 5. **Dark house spearing.** Taking fish by spearing from or within a dark house
 5.7 is allowed on Minnesota-South Dakota boundary waters according to items A to F G.

5.8 *[For text of item A, see Minnesota Rules]*

5.9 B. Carp, buffalo, sheepshead, suckers, redhorse, bowfin, and burbot, ~~and gar~~ may
 5.10 be taken by spearing and possessed without limit.

5.11 C. Longnose and shortnose gar may be taken with a spear. The possession limit
 5.12 for all gar is ten in aggregate.

5.13 ~~E. D.~~ Northern pike may be taken with a spear and the possession limit is three.

5.14 ~~D. E.~~ Catfish may be taken by spear, except on Bois De Sioux River from the
 5.15 White Rock Dam to the North Dakota border. The possession limit is five. Only one fish
 5.16 may be over 24 inches.

5.17 ~~E. F.~~ A person may not have a spear in possession on or near the water or ice of
 5.18 Minnesota-South Dakota boundary waters at any time, except during the open season for
 5.19 spearing.

5.20 ~~F. G.~~ Possession includes personal possession and possession in a vehicle.

6.1 Subp. 3. **Species, seasons, and limits on Minnesota-Wisconsin boundary waters.** To
 6.2 the extent that chapter 6264 is inconsistent with this part, the provisions of chapter 6264
 6.3 apply. Lake sturgeon are designated under part 6264.0400, subpart 90. Except as provided
 6.4 in chapter 6264, the following applies to the species, seasons, and limits for taking fish on
 6.5 Minnesota-Wisconsin boundary waters:
