**Department of Natural Resources** 1.1 1.2 Adopted Expedited Emergency Game and Fish Rules: 2023 Deer Seasons and Special 1.3 Hunts 6230.0290 BECKLIN HOMESTEAD PARK WILDLIFE MANAGEMENT AREA. 1.4 Subpart 1. Open hunting. The Becklin Homestead Park Wildlife Management Area 1.5 1.6 is open to hunting and trapping during the established seasons only to hunters and trappers with disabilities and their able-bodied partners during: 1.7 A. disabled hunters and trappers who meet the requirements of the established 1.8 seasons according to Minnesota Statutes, section 97B.055, subdivision 3, paragraphs (a) 1.9 and (b):; and 1.10 B. the special hunt described under subpart 2. 1.11 Subp. 2. Special hunt. 1.12 A. The Becklin Homestead Park Wildlife Management Area is open September 1.13 16 to December 31 for taking antlerless deer and legal bucks by archery as described in this 1.14 subpart. No more than 20 permits shall be issued to hunters with disabilities. Capable Partners 1.15 is the sponsor and hunters with disabilities and able-bodied partners must meet any 1.16 requirements of the sponsoring organization. Hunters with disabilities and able-bodied 1.17 partners may use bonus tags. 1.18 1.19 B. Hunters with disabilities must be accompanied by an able-bodied partner each time they hunt. Hunters with disabilities must purchase and possess an archery deer-hunting 1.20 license. The bag limit for hunters with disabilities is two deer, one of which may be a legal 1.21 buck. 1.22 C. Able-bodied partners must stay within 100 yards of the hunter with disabilities 1.23 and may take only legal antlerless deer. Able-bodied partners must purchase and possess 1.24 an archery license. The bag limit for able-bodied partners is one antlerless deer. 1.25

Subp. 2. Areas. Archery special bow and arrow hunt permits are valid in areas
designated by the commissioner and published in the annual hunting regulations booklet.
Unless otherwise specified, hunters must possess a valid archery special hunt permit for the
archery special hunt areas under this subpart. In addition to complying with the requirements
of this part, hunters who are hunting under an archery special hunt permit must meet any
requirements of the municipality, park, or area in which the special hunt occurs and of any

Youths participating in youth special deer seasons must obtain a license for taking deer by firearms, valid for any season option, by the beginning date of the special season. A youth special season participant may take one deer, which must be antlerless according to the bag limits under part 6232.1750. One bonus permit may be used in any deer permit area where bonus permits are valid during the regular firearms deer season. A legal buck taken during the youth special deer season applies to the statewide limit for legal bucks prescribed in part 6232.0300, subpart 8. An adult mentor age 18 or older authorized by the youth's parent or guardian must accompany the youth hunter hunters ages ten to 13 at all times during the hunt. The accompanying adult may not hunt, except when hunting in an early antlerless deer permit area. Party hunting is not allowed. The blaze orange or pink requirements in Minnesota Statutes, section 97B.071, paragraph (a), apply to all hunters and trappers, and all adult mentors of youth hunters, in the areas open to firearms deer hunting during the youth special seasons established in this part.

Subp. 2. Open areas; date. The Whitewater Game Refuge and all deer permit areas open to firearms deer hunting during the statewide A and B seasons, except Itasca State Park deer permit area 287, are open for the youth special deer season to youth who are at least ten years of age and under 18 years of age at the time of the hunt. Dates for the 2023 youth special deer season are October 19 to 22.
