1.2 **Adopted Expedited Emergency Game and Fish Rules: 2023 Deer Seasons and Special**
1.3 **Hunts**

1.4 **6230.0290 BECKLIN HOMESTEAD PARK WILDLIFE MANAGEMENT AREA.**

1.5 Subpart 1. **Open hunting.** The Becklin Homestead Park Wildlife Management Area
1.6 is open to hunting and trapping ~~during the established seasons~~ only to hunters and trappers
1.7 with disabilities and their able-bodied partners during:

1.8 A. ~~disabled hunters and trappers who meet the requirements of the established~~
1.9 seasons according to Minnesota Statutes, section 97B.055, subdivision 3, paragraphs (a)
1.10 and (b); and

1.11 B. the special hunt described under subpart 2.

1.12 Subp. 2. **Special hunt.**

1.13 A. The Becklin Homestead Park Wildlife Management Area is open September
1.14 16 to December 31 for taking antlerless deer and legal bucks by archery as described in this
1.15 subpart. No more than 20 permits shall be issued to hunters with disabilities. Capable Partners
1.16 is the sponsor and hunters with disabilities and able-bodied partners must meet any
1.17 requirements of the sponsoring organization. Hunters with disabilities and able-bodied
1.18 partners may use bonus tags.

1.19 B. Hunters with disabilities must be accompanied by an able-bodied partner each
1.20 time they hunt. Hunters with disabilities must purchase and possess an archery deer-hunting
1.21 license. The bag limit for hunters with disabilities is two deer, one of which may be a legal
1.22 buck.

1.23 C. Able-bodied partners must stay within 100 yards of the hunter with disabilities
1.24 and may take only legal antlerless deer. Able-bodied partners must purchase and possess
1.25 an archery license. The bag limit for able-bodied partners is one antlerless deer.

2.1 **6232.0200 DEFINITIONS.**2.2 *[For text of subparts 1 to 4, see Minnesota Rules]*2.3 Subp. 4a. **Deer permit area.** "Deer permit area" means an area of the state consisting
2.4 of one or more deer registration blocks according to part 6232.1750. Deer permit areas open
2.5 for taking legal bucks and antlerless deer during the deer season are defined as follows:2.6 A. ~~"intensive three-deer limit deer permit area," "two-deer limit deer permit area,"~~
2.7 ~~and "managed five-deer limit deer permit area" means a mean deer permit area~~ areas where
2.8 taking deer of either sex is authorized and ~~multiple~~ bonus permits are authorized within bag
2.9 limits for each area as prescribed by the commissioner;2.10 B. "antlerless lottery deer permit area" means a deer permit area where taking:2.11 *[For text of subitems (1) and (2), see Minnesota Rules]*2.12 (3) either-sex deer is authorized by an archery deer license; ~~and~~2.13 C. ~~"hunter choice either-sex deer permit area"~~ "either-sex deer permit area" means a deer permit area where
2.14 taking one deer of either sex is authorized; and2.15 D. "bucks-only deer permit area" means a deer permit area where only legal bucks
2.16 may be taken.2.17 *[For text of subparts 5 to 12, see Minnesota Rules]*2.18 Subp. 13. Fawn. "Fawn" means any deer less than one year of age.2.19 Subp. 14. Chronic wasting disease early detection management zone. "Chronic
2.20 wasting disease early detection management zone" means deer permit areas 604, 605, 661,
2.21 679, and 684.2.22 Subp. 15. Chronic wasting disease persistent infection zone. "Chronic wasting
2.23 disease persistent infection zone" means deer permit areas 643, 644, 645, 646, 647, 648,
2.24 649, and 655.

3.1 Subp. 16. Chronic wasting disease surveillance zone. "Chronic wasting disease
3.2 surveillance zone" means deer permit areas 101, 110, 197, 201, 233, 255, 256, 257, 259,
3.3 260, 262, 263, 265, 268, 287, 293, 341, and 342 and the portion of deer permit area 169
3.4 west of State Trunk Highway 6.

3.5 **6232.0300 GENERAL RESTRICTIONS FOR TAKING DEER.**

3.6 Subpart 1. **Season options, regular firearms.** ~~A firearm deer hunter may purchase~~
3.7 ~~a firearm license valid for the regular firearms deer season or a youth firearms license. A~~
3.8 ~~muzzleloader deer hunter may purchase a muzzleloader license valid for the muzzleloader~~
3.9 ~~season or a youth muzzleloader license. For the regular firearm season, a hunter must select~~
3.10 ~~either the A or B season and this option will be printed on the license at the time of purchase.~~
3.11 A person may ~~only~~ hunt deer by firearms only within the selected ~~season option indicated~~
3.12 ~~on the person's firearm license, except:~~

3.13 A. as prescribed in part 6232.1970, subpart 2;

3.14 B. a firearm license for any season option is valid in ~~the Metropolitan Deer~~
3.15 ~~Management Zone~~ deer permit area 701 under part 6232.4700, subpart 158; the chronic
3.16 wasting disease early detection management zone; and the chronic wasting disease persistent
3.17 infection zone; and

3.18 C. youth firearm license holders with a license issued under Minnesota Statutes,
3.19 section 97A.475, subdivision 2 or 3, may hunt deer in both the statewide A and late southeast
3.20 B seasons.

3.21 *[For text of subpart 2, see Minnesota Rules]*

3.22 Subp. 3. **Party hunting.**

3.23 A. A party is a group of two or more licensed deer hunters who are afield hunting
3.24 together and are all using firearms or all using archery equipment.

4.1 B. A member of a party may kill a legal buck or antlerless deer for another member
4.2 of the party who has an unused tag valid for that deer, ~~except:~~

4.3 ~~A. as provided by Minnesota Statutes, section 97B.301; and,~~

4.4 ~~B. in all 300 series deer permit areas as prescribed in part 6232.1300, subpart 3,~~
4.5 ~~where unused tags can be used on antlerless deer only.~~

4.6 C. A mixed-weapons group is considered two separate parties.

4.7 D. Persons issued permits under Minnesota Statutes, section 97B.055, subdivision
4.8 3, who are hunting in a an antlerless lottery deer permit area and do not have an either-sex
4.9 permit may not tag antlerless deer for another member of the party.

4.10 *[For text of subparts 4 and 5, see Minnesota Rules]*

4.11 Subp. 6. ~~License purchase~~ Bonus permits and validation.

4.12 A. A bonus permit may be purchased ~~any time throughout the open deer seasons.~~
4.13 ~~Bonus permits are valid immediately upon purchase, as long as the purchaser has a valid~~
4.14 ~~regular license. When a regular license is purchased after the start of the season for that~~
4.15 ~~license, a bonus permit is not valid until the waiting period has expired for the regular~~
4.16 ~~license.~~ before and during the open archery, firearms, and muzzleloader deer seasons. A
4.17 bonus permit is not valid unless:

4.18 (1) it is issued before legal shooting hours on the day it is first used; and

4.19 (2) the hunter's regular license is valid under Minnesota Statutes, section
4.20 97A.411, subdivision 3.

4.21 B. Bonus permits are valid for taking deer by archery, firearms, or muzzleloader
4.22 license holders in areas where taking more than one deer is authorized, except where taking
4.23 or tagging more than one deer is authorized solely by landowner permits.

5.1 C. Unless otherwise specified, bonus permits are valid in archery, firearms, and
5.2 muzzleloader special hunts, including early- or late-season hunts.

5.3 ~~B. D.~~ Before a deer is moved from the site of kill, ~~the person tagging the deer~~
5.4 ~~must validate the tag~~ a site tag must be validated at the site of kill by the licensed deer hunter
5.5 whose tag is being used on the deer. Validation consists of using a knife or similar sharp
5.6 object to cut out or a pen to indelibly mark the appropriate notches on the tag indicating:

- 5.7 (1) the month the deer was taken;
- 5.8 (2) the date the deer was taken; and
- 5.9 (3) the time of day the deer was taken.

5.10 *[For text of subpart 7, see Minnesota Rules]*

5.11 Subp. 8. **Bag limit.**

5.12 A. Except in deer permit area 643, 645, 646, 647, 648, 649, and 655, a person
5.13 may not tag more than one legal buck per calendar year using any combination of licenses.
5.14 In deer permit areas 643, 645, 646, 647, 648, 649, and 655, a person may tag one legal buck
5.15 during the archery season, the firearms season, and the muzzleloader season, but not more
5.16 than three legal bucks per calendar year. A person may not tag more than one deer during
5.17 a license year by any method, except as authorized in ~~items A to G~~ this subpart.

5.18 ~~A. B.~~ In deer permit areas designated as ~~managed or intensive~~ two-deer limit,
5.19 three-deer limit, or five-deer limit, a person may tag deer with an archery, firearms, or
5.20 muzzleloader license.

5.21 ~~B. C.~~ A person may tag a deer by archery, firearm, or muzzleloader with a bonus
5.22 permit in specified areas as prescribed in this chapter.

6.1 ~~€. D.~~ In no case may a person tag more than five deer per year by firearms, archery,
6.2 muzzleloader, or all methods combined, except additional deer may be taken as provided
6.3 in items ~~D~~ E, subitem ~~(4)~~; E; (5), and F; ~~and G~~.

6.4 ~~D. E.~~ Except as provided in ~~items E and item F~~, the total bag limits by deer permit
6.5 area are as follows:

6.6 (1) the total bag limit for antlerless lottery, ~~hunter choice either-sex~~, and
6.7 ~~youth-only antlerless~~ bucks-only deer permit areas is one deer;

6.8 (2) the total aggregate bag limit for ~~managed~~ two-deer limit deer permit areas
6.9 is two deer;

6.10 (3) the total aggregate bag limit for ~~intensive~~ three-deer limit deer permit
6.11 areas is ~~five~~ three deer; ~~and~~

6.12 (4) the total aggregate bag limit for five-deer limit deer permit areas is five
6.13 deer; and

6.14 ~~(4)~~ (5) in addition to the total bag limits under subitems (1) to ~~(3)~~ (4), a person
6.15 with a free landowner deer license may take one ~~additional~~ antlerless deer on land owned
6.16 or leased by the person in ~~managed~~ either-sex, two-deer limit, three-deer limit, and intensive
6.17 five-deer limit deer permit areas. Landowner licenses are also valid during late hunts and
6.18 the early antlerless deer season.

6.19 ~~E. F.~~ Up to ~~two~~ three antlerless deer may be taken in the early antlerless deer
6.20 permit areas as prescribed in part 6232.1750. These deer may be taken in addition to the
6.21 bag limit established in item ~~€ D~~.

6.22 ~~F. Hunters hunting in the Metropolitan Deer Management Zone under part~~
6.23 ~~6232.4700, subpart 158, may take and tag an unlimited number of deer.~~

7.1 ~~G. Muzzleloader and archery deer hunters hunting in deer permit areas 300 to 399~~
7.2 ~~may take deer under the most liberal bag limits prescribed for the deer permit area.~~

7.4 **6232.0400 REGISTRATION OF DEER.**

7.6 **Subp. 2. Registration requirements.**

7.7 *[For text of item A, see Minnesota Rules]*

7.8 **B. Deer must be registered according to item A:**

7.9 (1) before the deer is processed either privately or commercially; and

7.10 (2) within ~~24~~ 48 hours after the ~~close of the season in which the deer was~~
7.11 taken.

7.12 *[For text of items C and D, see Minnesota Rules]*

7.13 *[For text of subpart 3, see Minnesota Rules]*

7.14 **Subp. 4. General provisions for registration of deer.**

7.15 A. Registration agents are not required to inspect deer at registration stations.

7.16 Legally registered deer may be transported anytime during or after the deer hunting season,
7.17 except as prescribed in subparts 6 to 9.

7.18 B. No part of the carcass, except skin or entrails, may be removed until after the
7.19 deer has been registered using one of the methods described in subpart 2, except that deer
7.20 may be quartered prior to registration as long as all parts remain together ~~and are presented~~
7.21 ~~for registration~~ and the head of the deer remains attached to one quarter. A person may not
7.22 process a deer unless it has been registered as evidenced by a possession tag or registration
7.23 confirmation number.

8.1 C. Authorized department staff may transport carcasses statewide when conducting
8.2 department operations.

8.3 Subp. 5. [See repealer.]

8.4 Subp. 6. Deer carcasses in chronic wasting disease early detection management
8.5 zone.

8.6 A. Except as provided in items B, D, E, F, and H, carcasses of wild deer harvested
8.7 by hunters, killed by vehicles, or killed in any other manner in the chronic wasting disease
8.8 early detection management zone must remain in the zone until the results of a test for
8.9 chronic wasting disease show the disease has not been detected in the deer.

8.10 B. Cut and wrapped meat, quarters, or other portions of meat from a deer taken
8.11 in the chronic wasting disease early detection management zone may be transported outside
8.12 the zone if no part of the spinal column or head is attached. Antlers, hides, teeth, finished
8.13 taxidermy mounts, antlers attached to skull caps that are cleaned of all brain tissue, and
8.14 whole skulls that are cleaned of all brain tissue may be transported outside the chronic
8.15 wasting disease early detection management zone.

8.16 C. Except as provided in item G, deer, except fawns, taken on November 4 or 5,
8.17 2023, in the chronic wasting disease early detection management zone must be submitted
8.18 at a designated sampling station listed on the Department of Natural Resources website for
8.19 chronic wasting disease sampling within 24 hours of harvest and before being transported
8.20 out of the chronic wasting disease early detection management zone.

8.21 D. Carcasses of deer taken in deer permit area 661 as defined in part 6232.4700,
8.22 subpart 104, may be transported from deer permit area 661 into the incorporated and
8.23 unincorporated municipal boundaries of the following cities: Alvarado, Angus, Beltrami,
8.24 Crookston, Euclid, Nielsville, Oslo, and Warren.

9.1 E. Carcasses of deer taken in deer permit area 679 as defined in part 6232.4700,
9.2 subpart 35, may be transported from deer permit area 679 into the incorporated and
9.3 unincorporated municipal boundaries of the following cities: Bowstring, Deer River,
9.4 Goodland, Hill City, Jacobson, Nashwauk, Ox Hide, Pengilly, Remer, Swan River, Talmoon,
9.5 and Zemple.

9.6 F. Carcasses of deer taken in deer permit area 684 as defined in part 6232.4700,
9.7 subpart 85, may be transported from deer permit area 684 into the incorporated and
9.8 unincorporated municipal boundaries of the following cities: Bagley, Blackduck, Lake
9.9 George, Laporte, Nebish, and Shevlin.

9.10 G. Hunters who are submitting samples via the department hunter mail-in sample
9.11 program rather than at a check station must have their samples postmarked within 72 hours
9.12 of harvest. Hunters must obtain mail-in kits before taking the deer to comply with the
9.13 sampling requirement.

9.14 H. An enrolled member of Minnesota Tribal governments, as defined under
9.15 Minnesota Statutes, section 10.65, subdivision 2, who takes deer on lands held in trust by
9.16 the Minnesota Tribal government that the member is enrolled in is exempt from this subpart.

9.17 **Subp. 7. Deer carcasses in chronic wasting disease persistent infection zone.**

9.18 A. Except as provided in items B, E, and F, carcasses of a wild deer harvested by
9.19 hunters, killed by vehicles, or killed in any other manner in the chronic wasting disease
9.20 persistent infection zone must remain in the zone until results of a test for chronic wasting
9.21 disease show the disease has not been detected in the deer.

9.22 B. Cut and wrapped meat, quarters, or other portions of meat from a deer from
9.23 the chronic wasting disease persistent infection zone may be transported out of the zone if
9.24 no part of the spinal column or head is attached. Antlers, hides, teeth, finished taxidermy
9.25 mounts, antlers attached to skull caps that are cleaned of all brain tissue, and whole skulls

10.1 that are cleaned of all brain tissue may be transported outside the chronic wasting disease
10.2 persistent infection zone.

10.3 C. Except as provided in item D, deer, except fawns, taken on November 4 or 5,
10.4 2023, in the chronic wasting disease persistent infection zone must be submitted at a
10.5 designated sampling station listed on the Department of Natural Resources website for
10.6 chronic wasting disease sampling within 24 hours of harvest and before being transported
10.7 out of the chronic wasting disease persistent infection zone.

10.8 D. Hunters who are submitting samples via the department hunter mail-in sample
10.9 program rather than at a check station must have their samples postmarked within 72 hours
10.10 of harvest. Hunters must obtain mail-in kits before taking the deer to comply with the
10.11 sampling requirement.

10.12 E. Carcasses of deer taken in the chronic wasting disease persistent infection zone
10.13 may be transported from that zone into incorporated and unincorporated municipal boundaries
10.14 of the following cities: Adams, Elkton, Dexter, Kasson, Mantorville, Pine Island, Oronoco,
10.15 and Plainview.

10.16 F. An enrolled member of Minnesota Tribal governments, as defined under
10.17 Minnesota Statutes, section 10.65, subdivision 2, who takes deer on lands held in trust by
10.18 the Minnesota Tribal government that the member is enrolled in is exempt from this subpart.

10.19 **Subp. 8. Deer carcasses in chronic wasting disease surveillance zone.**

10.20 A. Except as provided in items B and C, deer, except fawns, taken on November
10.21 4 or 5, 2023, in the chronic wasting disease surveillance zone must be submitted at a
10.22 designated sampling station listed on the Department of Natural Resources website for
10.23 chronic wasting disease sampling within 24 hours of harvest and before being transported
10.24 out of the chronic wasting disease surveillance zone.

11.1 B. Hunters who are submitting samples via the department hunter mail-in sample
11.2 program rather than at a check station must have their samples postmarked within 72 hours
11.3 of harvest. Hunters must obtain mail-in kits before taking the deer to comply with the
11.4 sampling requirement.

11.5 C. An enrolled member of Minnesota Tribal governments, as defined under
11.6 Minnesota Statutes, section 10.65, subdivision 2, who takes deer on lands held in trust by
11.7 the Minnesota Tribal government that the member is enrolled in is exempt from this subpart.

11.8 **Subp. 9. Deer taken during disease management hunts.**

11.9 A. Except as provided in items B and C and within 24 hours after the hunt ends,
11.10 deer, except fawns, taken during a disease management hunt under part 6232.1600, subpart
11.11 9, must be submitted for mandatory testing for chronic wasting disease at a designated
11.12 sampling station listed on the Department of Natural Resources website.

11.13 B. Hunters who are submitting samples via the department hunter mail-in sample
11.14 program rather than at a check station must have their samples postmarked within 72 hours
11.15 of harvest. Hunters must obtain mail-in kits before taking the deer to comply with the
11.16 sampling requirement.

11.17 C. An enrolled member of Minnesota Tribal governments, as defined under
11.18 Minnesota Statutes, section 10.65, subdivision 2, who takes deer on lands held in trust by
11.19 the Minnesota Tribal government that the member is enrolled in is exempt from this subpart.

11.20 **6232.0700 LEGAL DEER BY ARCHERY.**

11.21 Antlerless deer and legal bucks may be taken by archery, except that archery hunters
11.22 may not take antlerless deer in ~~lottery~~ bucks-only deer permit areas ~~that have no either-sex~~
11.23 ~~permit quota~~ or in antlerless lottery deer permit areas that have a quota of youth antlerless
11.24 permits for firearms deer hunters under part 6232.1800.

12.1 **6232.0800 ARCHERY SPECIAL HUNT AREAS AND PROCEDURES.**12.2 [For text of subpart 1, see Minnesota Rules]

12.3 Subp. 2. **Areas.** Archery special bow and arrow hunt permits are valid in areas
12.4 designated by the commissioner and published in the annual hunting regulations booklet.
12.5 Unless otherwise specified, hunters must possess a valid archery special hunt permit for the
12.6 archery special hunt areas under this subpart. In addition to complying with the requirements
12.7 of this part, hunters who are hunting under an archery special hunt permit must meet any
12.8 requirements of the municipality, park, or area in which the special hunt occurs and of any
12.9 sponsoring organization. Hunt participants must stay within any boundaries that are
12.10 prescribed by the sponsoring organization, by maps provided during a prehunt orientation,
12.11 or by posting. The following archery special hunt areas are established for the 2023 season:

12.12 A. portions of the Pin Oak Prairie Scientific and Natural Area in Fillmore County
12.13 are open October 1 to November 30 for taking antlerless deer and legal bucks. No more
12.14 than eight permits shall be issued. The bag limit is five deer. This is special hunt 926;

12.15 B. portions of Carleton State Game Refuge and Arboretum in Dakota and Rice
12.16 Counties are open November 23 to December 31 for antlerless deer and legal bucks in an
12.17 earn-a-buck hunt. No more than 40 permits shall be issued. Hunters must obtain written
12.18 permission from the landowner. The bag limit is five deer. This is special hunt 972;

12.19 C. J.C. Hormel Nature Center and portions of the city of Austin in Mower County
12.20 are open October 1 to December 31 for taking antlerless deer and legal bucks in an
12.21 earn-a-buck hunt. No more than 60 permits shall be issued. The bag limit is three deer. This
12.22 is special hunt 973;

12.23 D. portions of the Vermillion Highlands Research, Recreation, and Wildlife
12.24 Management Area in Dakota County are open September 16 to October 27 for taking
12.25 antlerless deer and legal bucks. No more than 60 permits shall be issued. The bag limit is
12.26 three deer. This is special hunt 975;

13.1 E. portions of the city of New Ulm in Brown County are open October 14 to
13.2 December 31 for taking antlerless deer and legal bucks in a double earn-a-buck hunt. Hunters
13.3 must register two antlerless deer before harvesting a legal buck. No more than 56 permits
13.4 shall be issued. The bag limit is three deer. This is special hunt 923;

13.5 F. portions of the city of Red Wing in Goodhue County are open September 16
13.6 to December 31 for taking antlerless deer and legal bucks. Portions of Red Wing as identified
13.7 on maps provided by the hunt administrator are an earn-a-buck hunt. Permits to hunt are
13.8 unlimited. The bag limit is five deer. This is special hunt 977;

13.9 G. portions of the city of Redwood Falls in Redwood County are open September
13.10 16 to December 31 for taking antlerless deer and legal bucks in a double earn-a-buck hunt.
13.11 Hunters must register two antlerless deer before harvesting a legal buck. No more than 20
13.12 permits shall be issued. The bag limit is three deer. This is special hunt 978;

13.13 H. portions of the city of Duluth in St. Louis County are open September 16 to
13.14 December 31 for taking antlerless deer and legal bucks. No more than 400 permits shall be
13.15 issued. The bag limit is three deer. This is special hunt 980;

13.16 I. portions of the city of Mankato in Blue Earth County are open September 16
13.17 to December 31 for taking antlerless deer and legal bucks in an earn-a-buck hunt. No more
13.18 than 40 permits shall be issued. The bag limit is five deer. This is special hunt 981;

13.19 J. portions of the city of Granite Falls in Yellow Medicine County are open
13.20 September 16 to December 31 for taking antlerless deer only. No more than ten permits
13.21 shall be issued. The bag limit is one deer. This is special hunt 982;

13.22 K. portions of the city of Ortonville in Big Stone County are open September 16
13.23 to December 31 for taking antlerless deer and legal bucks in an earn-a-buck hunt. No more
13.24 than 30 permits shall be issued. The bag limit is five deer. This is special hunt 983;

14.1 L. portions of the city of Canby in Yellow Medicine County are open September
14.2 16 to December 31 for taking antlerless deer and legal bucks. No more than 20 permits shall
14.3 be issued. The bag limit is two deer. This is special hunt 984;

14.4 M. portions of the city of Bemidji in Beltrami County as identified on maps
14.5 provided by the hunt administrator are open September 16 to December 31 for taking
14.6 antlerless deer and legal bucks. No more than 22 permits for the northeast hunt area and 22
14.7 permits for the west hunt area shall be issued. The bag limit is five deer. This is special hunt
14.8 985;

14.9 N. portions of Bemidji Regional Airport in Beltrami County are open September
14.10 16 to December 31 for taking antlerless deer and legal bucks. No more than 20 permits shall
