1.9 B. This item applies while a person is on or fishing in the waters listed under item

1.10 C. The angling season for walleye begins May 11, 2024, at 12:01 a.m. and continues to

1.11 February 23, 2025, at 11:59 p.m. The following daily and possession limits apply:

1.12 ~~(1) the daily and possession limit for walleye is two fish, of which not more~~
1.13 ~~than one walleye shall be over 26 inches in length;~~

1.14 ~~(2) all walleye in possession must be less than 17 inches or greater than 26~~
1.15 ~~inches in length;~~

1.16 ~~(3) all walleye that are 17 inches to 26 inches in length, inclusive, must be~~
1.17 ~~immediately returned to the water; and~~

1.18 ~~(4) a person's statewide bag limit shall not include more than two walleye~~
1.19 ~~taken from Upper Red Lake and the tributaries listed under item C.~~

1.20 (1) beginning at 12:01 a.m. May 11, 2024, the daily and possession limit for
1.21 walleye is three fish, of which not more than one walleye may be over 17 inches in length.

1.22 This subitem is effective until 11:59 p.m. June 14, 2024; and

2.1 (2) beginning at 12:01 a.m. June 15, 2024, the daily and possession limit for
 2.2 walleye is four fish, of which not more than one walleye may be over 17 inches in length.
 2.3 This subitem is effective until 11:59 p.m. February 23, 2025.
