## LANDS & MINERALS

### Chapter 57 SF 2096 HF 2410

#### Omnibus Environment and Natural Resources Finance Bill

##### **Article 1, Sec. 4, Subd. 2. Mineral Management Account**

\$5,896,000. Ensures that the state is properly paid for the state owned minerals mined by companies under leases negotiated by the Department of Natural Resources.

##### **Article 1, Sec. 4, Subd. 2. Land Records Management System**

\$1,902,000. Update the Department of Natural Resources land record system to improve its utility for DNR staff, other government agencies, and the public.

##### **Article 1, Sec. 4, Subd. 2. Land Asset Management**

\$1,000,000. Accelerate land transactions focusing on larger and more expeditious land exchanges, more expeditious land acquisitions, and developing plans for better managing the state's land base.

##### **Article 1, Sec. 4, Subd. 2. Reporting Requirements**

\$15,000. Requirement for preparation of a report to identify minimum legal and conservation standards that could be applied to conservation easements acquired with public money.

##### **Article 1, Sec. 77. Minerals Coordinating Committee**

This extends the life of a committee that has provided advice on mineral issues to the DNR and other agencies since 1978. The committee was scheduled to sunset on June 30, 2007. This date has been extended to 2011.

##### **Article 1, Sec. 78. Mineral Management Program**

Reinstate use of mineral income to support DNR's Mineral Management Program.

**Chapter 129 SF 496          HF 1360**  
**Landowner Bill of Rights**  
**Omnibus Data Practices Bill**

**OVERVIEW**

This bill contains language that authorizes the Department to provide appraised value information to the potential sellers of land.

Real property; appraisal data. (a), (b), (c). Confidential or protected nonpublic data.

**Chapter 131 SF 1131          HF 1021**  
**Omnibus Environment and Natural Resources Policy Bill**

**Article 2, Sec. 1, Subd. 3. Minimal Value Acquisition.**

Appraisals have become very expensive and time consuming. The Department has successfully used means other than appraisals for evaluation of lands it has been selling over the past few years. These land evaluations would only be used with the approval of the landowner, and would use published data related to the land being purchased.

**Article 2, Sec. 2, Subd. 5. Owner's Rights.**

Resolution of current statutory language in the Land Owner's Bill of Rights and The Minnesota Data Practices Act, that gives conflicting directions on the type of appraisal data that can be shared with a willing seller of land. The language contained in the bill will allow the DNR to share with a willing seller the value of their land prior to making the landowner declare their intention to sell.

### **Chapter 2 HF 110 HF 38 Great Lakes-St. Lawrence River Basin Water Resources Compact**

#### **OVERVIEW**

Chapter 2, the Great Lakes-St. Lawrence River Basin Water Resources Compact, is a binding agreement between the 8 Great Lake states to better protect the health of the Great Lakes. This compact was developed over the last 6 years and Minnesota is the first to pass the compact. The compact needs to be passed by the other 7 states and approved by Congress before it becomes effective. Minnesota's regulatory program is stronger than the compact requires and new regulations are not needed in Minnesota.

\$310,000/\$310,000. Grants associated with implementation of the Red River Mediation Agreement.

\$2,250,000. Funding will accelerate stream gauging, continue lakeshed delineation, and increase shoreland stewardship. One time appropriation.

**Regulation of Shoreland Resorts**

**OVERVIEW**

Chapter 92 provides a definition of resorts and preempts local ordinances that do not allow maintenance and replacement or expansions required to minimally comply with federal, state or local codes. Allows for maintenance and repair of aging or damaged structures and expansions of structures if required to comply with current codes.

### **Chapter 36 SF 420 HF 1106 Firewood Pest Control, Sale and Distribution Regulation**

#### **OVERVIEW**

Chapter 36 addresses the issue of recreationally used firewood serving as a vector for the spread of invasive species. Restricts firewood from being brought onto state-administered lands unless the Commissioner of the Department of Natural Resources approves that firewood.

\$14,434,000. Wildfires - Prevention, Presuppression, and Suppression Costs. Costs of emergency firefighting and other costs incurred under Minn. Stat. Sec. 88.12.

#### **Article 1, Sec. 4, Subd. 4.**

\$700,000. Forestry Information System (FORIST). Funding for the Forestry Information System (FORIST), other information systems, and forest management.

**Article 1, Sec. 4, Subd. 4.**

\$521,000. Ecological Classification System (ECS). Implementation of ecological classification system (ECS) standards on forested landscapes.

**Article 1, Sec. 4, Subd. 4**

**Forest Management Investment Account**

\$780,000/\$780,000. For implementation of the Sustainable Forest Resources Act.

\$40,000. For a grant to the University of Minnesota. The funding will be used for preparation of a statewide plan to address fragmentation and parcelization of large blocks of forest land in the state.

\$200,000. Forest Resources Research Advisory Committee. This funding will provide direction on research topics recommended by the Governor's Task Force on the Competitiveness of Minnesota's Primary Forest Products Industry.

\$110,000. Firewood Limitation. This funding to be used for firewood restrictions prohibitions on state lands. Monies will be used for the development and implementation of statewide information and education campaign regarding restrictions on transport, storage, and use of non-approved firewood on state-administered lands. This is a one-time appropriation.

\$1,000,000/\$1,000,000. Technical and Cost-Share Assistance to Non-Industrial Private Forest Landowners.

\$200,000/\$200,000. Land Asset Management Demands. Address escalating demands, including boundary disputes, access easements, and sale, exchange, and acquisition of forest lands.

\$1,500,000. From the Forest Management Investment Account to be used for relief payments to state timber sale permit holders. This is a one-time appropriation.

\$75,000. Minnesota Forest Resources Council. Task force on forest protection. Line item veto by Governor.

\$75,000. Allocation of Grants (through Commissioner, DNR). Cities, counties, townships, special recreation areas, and park and recreation boards in cities of the first class for the identification, removal, disposal, and replacement of dead or dying shade trees lost to forest pests or disease. Line item veto by Governor.

\$200,000. Grant to Natural Resources Research Institute. Silvicultural research to improve the quality and quantity of timber fiber. Appropriation must be matched by cash or in-kind contributions from forest products industry members of Minnesota Forest Productivity Research Cooperative.

### **Forestry Policy**

Creates a forest resource assessment products and services account in the state treasury in the natural resources fund.

### **Use of State Forest Land: Fees**

#### **Article 1, Sec. 56**

Credit fees collected for use of state forest lands (e.g., dog sled races, dog trials, snowmobile races, sports car rallies) to the special revenue fund and annually appropriated to the DNR commissioner.

#### **Article 1, Sec. 76 & Section 148.**

Returns a surety bond or letter of credit to a holder of a forfeited timber sale permit if harvest operations have not been started (the permittee will still be responsible to the state for the required down payment on the permit).

#### **Article 1, Sec. 148.**

Allows counties to sell timber, including biomass, as appraised or scaled, instead of just as scaled.

Broadens practices eligible for cost-share dollars within the Minnesota Releaf program. Outlines community eligibility for assistance grants.

Reassigns inspector certification program to the DNR.

Authorizes Minnesota Department of Agriculture to make grants or enter into agreements with municipalities, nurseries, etc. on issues related to new and emerging plant pests.

## **Relief Payments for Timber Sale Permits**

Provides relief to holders of state timber sale permits (permittees) issued on or after June 1, 2004, but before April 1, 2006, for which there has been no harvesting, road building, or other on-the-ground actions taken.

\$3,996,000/\$3,996,000. State park and recreation area operations.

Appropriation in Laws 2003, C. 128, Art. 1, Sec. 5, Subd. 6 provides initial appropriation of \$700,000 for cooperative project with the US Army Corps of Engineers to develop the Mississippi Park until June 30, 2009.

**Greenleaf Lake State Park**

Greenleaf State Park is renamed Greenleaf Lake State Recreation Area.

**Sec. 167, Subd. 1 and Subd. 2.**

**Greenleaf Lake State Recreation Area**

Adds lands to the statutory boundary of Greenleaf Lake State Recreation Area. Requests development of a comprehensive management plan for recreational opportunities in the area.

**Sec. 40, [85.0146], Subd. 1.**

**Cuyuna Country State Recreation Area Citizens Advisory Council**

Establishes advisory council, designates membership and provides for administrative functions.

**Sec. 41, Subd. 13.**

Cuyuna Country State Recreation Area. Eliminates permit or fees charged at the Croft Mine Historical Park and Portsmouth Mine Lake Overlook in the Cuyuna State Recreation Area, except for overnight camping.

**Article 1, Sec. 4, Subd. 6.**

**Wallop-Breaux Motor Boat**

\$1,965,000/\$2,040,000. Expenditures on water access sites according to the requirements of the federal sport and fish restoration program.

**Article 1, Sec. 4, Subd. 6.**

**Non-Motorized Forest Recreation**

\$400,000/\$400,000. Funding for the operation and maintenance of state forest non-motorized recreational trails and enforcement of state forest trail regulations.

**Article 1, Sec. 4, Subd. 6.**

**Wild & Scenic Rivers**

\$75,000/\$75,000. Provides funding to allow Trails and Waterways to focus on priority areas for monitoring and management of Wild and Scenic Easements.

**Article 1, Sec. 4, Subd. 6.**

**Natural Resources Fund Change Items**

**Grant-in-Aid Trails (ATV Fee Increase)**

\$1,175,000/\$1,325,000. Additional resources will be granted to local units of government to support the development and maintenance of ATV grant-in-aid trails.

**Article 1, Sec. 4, Subd. 6.**

**Trail Specialist (ATV Fee Increase)**

\$150,000/\$150,000. Funding to provide resources for additional staff specialists to assist and consult with on all-terrain vehicle grant-in-aid education and training for sustainable trail development and maintenance as well as providing training for public and private sector trail monitoring.

**Article 1, Sec. 4, Subd. 6.**

**Canoe Route Designations**

\$120,000 until expended in cooperation with local units of government, private individuals and groups, when feasible, to mark a canoe and boating route on the Redwood River. It will allow the DNR to map the river for recreational canoeing purposes and in cooperation with local governments identify and provide access and recreational points along the river.

**Article 1, Sec. 4, Subd. 6.**

**Snowmobile Grant-in-Aid.**

\$8,424,000/\$8,424,000. Monies from snowmobile trails and enforcement account in the natural resources fund for snowmobile grant-in-aid. Monies used to develop, maintain, and groom snowmobile trails throughout Minnesota.

**Article 1, Sec. 29, Subd. 5.**

**ATV Registration Fee Increases**

ATV registration fee increase from \$30 to \$45 dollars. Registration is good for three years.

**Article 1, Sec. 25. Minnesota Statutes 2006, Section 84.780, is amended:**

**84.780 Off-Highway Damage Account**

Extends sunset date of the OHV Damage Account until funds are expended. Changes existing language from "unpermitted" operation of OHVs to "illegal" operation of OHVs. Minn. Stat. Section 84.780 (2003) authorizes the Commissioner of Natural Resources to provide funds for the repair or restoration of property damaged by the unpermitted operation of OHVs subject to specific pre-conditions.

**Minimum Maintenance Forest Road Added to ATV Account**

Maintenance of minimum-maintenance forest roads designated under section 89.71, subd. 5, and county forest roads that are part of a designated trail system within state forest boundaries as established under section 89.021.

**Amends Laws of 2005, Special Session Chapter 1, Article 2, Sec. 3, Subd. 6.**

Extends local trail grant funding available until June 30, 2009.

**Amends Laws 2005, Special Session Chapter 1, Article 2, Sec. 11, Subd. 6,

Extends LCMR acquisition money for the Paul Bunyan Trail within the city of Bemidji until June 30, 2008. Agency recommended.

Restricts the use and development of off road vehicle (truck) trails in Cass, Crow Wing and Hubbard Counties.

Provides exemptions on ATV's 25 years old or older.

**84.777 Off-Highway Vehicle Use of State Lands Restricted**

(MS 2006, Sec. 84.777). Requires the Commissioner to establish seasons for OHV use. Commissioner may designate and post winter trails for OHV's. Requires the DNR to publish maps for trails open for OHV use, exempt from the mapping are forest access routes within state forests lying north of Highway 2.

\$2,300,000. Funding for programs and efforts to preserve, restore and enhance grassland/wetland complexes on public and private lands to meet Minnesota's long-term waterfowl and pheasant population goals, and improve water quality.

\$186,000/\$132,000. Acceleration of the wildlife health management program. Accelerated response to disease threats related to wildlife and their interactions with livestock, poultry and humans.

## Line Item Vetoes by Governor SF 2096

Senate File 2096, Chapter 57, the Omnibus Environment, Natural Resources & Energy bill was received, approved, signed, and delivered to the Secretary of state with the exception of the line-item vetoes listed below. All line item vetoes to the bill are listed.

- A \$150,000 appropriation, \$75,000 each year, in Chapter 57, Article 1, Section 4, for a shade-tree protection task force and grants.
- A \$10,000 appropriation in Chapter 57, Article 1, Section 4, for the Cuyuna Country State Recreation Area Citizens Advisory Council.
- A \$200,000 appropriation in Chapter 57, Article 1, Section 5, for a grant to the city of Gaylord for storm water and sewer reconstruction. BWSR.
- Page 142, line 142.19, Chapter 47, Article 2, Section 3, page 142. Center for Rural Policy and Development at Minnesota State University at Mankato to make a grant to a non-profit organization. Line item elimination of wording “each year” from the designated appropriated, which eliminates the appropriation in the second year.
