Meeting Notes

Objectives for this meeting were to:

- Go over updated recommendations document and implementation plan
- Discuss public feedback
- Understand next steps

Executive Summary Updates

- Updated to address questions such as Why ORTF requires an office. What problem is being resolved?
- Updated to include more information and clarity to the purpose of the office. How the office will operate.
- Reframing within the summary to be more succinct.

Public Engagement Feedback Summary

- Lots of feedback regarding concern for potential bias against motorized recreation vs. non-motorized recreation
 - o Idea of ORTF office is to prevent and minimize biases
 - Concern may have been raised due to vague language of the initial executive summary; prior to updates
 - Make exceedingly clear that the office would NOT be a policy maker or management branch but rather a voice for ALL outdoor recreation
- This was a public input opportunity/feedback tool and not scientific survey, therefore 209 respondents is a satisfactory sample size. Especially taking into consideration the commitment required to read all the information then provide feedback. However, in comparison to statewide, 209 respondents is not a large number illustrating the importance of an office to assist with communication efforts.

- As mentioned in the updated executive summary, 14 other states have established recreation offices and so we
 have opportunities to learn from these established offices
- Office purpose:
 - o Power to be a convening body
 - Convener for stakeholders
 - Magnify current projects and activities
 - No power to create policies or make changes that would benefit one recreation activity at the expense of another
 - o Promote economic benefit of outdoor recreation
 - Minimize conflict between user groups
- Reframing/re-ordering will be necessary of the full recommendations document in order to match that of the executive summary
 - Thorough edit by small group for final draft
 - o Emphasis on the economic benefit of having the office

Straw Poll Results

Next Steps

- Modifications needed to ensure that the main body of the recommendations document reflects the executive summary.
- Large group to make change to recommendations document via tracked changes and edits will be sent to small group
- Poll/executive summary will be sent to ORTF members who were not in attendance and their responses and any tracked changes/edits will be sent to the small group for review
- Small group to schedule meeting to discuss final edits and finalize document
- Final formal meeting to be scheduled with large group once document is finalized in order to cast votes; stress importance of FINAL meeting in March
 - o Offer the option to vote by email if someone is unable to attend final meeting
