The goal of the proposed project is to set back succession of lowland brush to enhance the habitat benefits to wildlife species requiring open landscape and brushland habitats. Maintaining the early successional brushland component to this landscape will help to maintain this site for use by a wide variety of wildlife species. Benefits from this project include improved herbaceous forage, fawning sites, and loafing cover for deer, and enhanced breeding, nesting and brood rearing habitat for a variety of both game and non-game brushland dependent avian species, such as the American woodcock, sharp-tailed grouse, snipe, sandhill crane, sedge wrens, Eastern bluebird, and golden-winged warbler. The short-eared owl, great gray owl, Northern harrier and American kestrel utilize brushland habitats as hunting grounds.

Additional bird species, such as the which currently inhabit the nearby sedge meadows and wet prairies, may also benefit from this project. By using prescribed fire as a management tool following mechanical treatment of these acres, we hope to increase breeding habitat for these rare members of the avian community.

As conditions warrant, the entire project might be done in winter 2009-2010, or in winter 2010-2011, or as scheduled above (160 acrea each winter).
