This project seeks to enhance 25 acres of grassland on the Maple River WMA. This site is currently vegetated with cool season non-native grasses with scattered trees and shrubs. There is a restored wetland adjacent to the project site and an aditional 120 plus acres of restored native grasslands that were also planted by MN Pheasants Inc. of Blue Earth County. Our project plan is to apply Rodeo (glyphosate) herbicide in the spring following a prescribed fire carried out by MN DNR. We will then seed the area with a no-till warm season grass drill using local eco-type seed as prescribed by the enabeling legislation for this grant program. The site will be mowed twice during the 2010 growing season to control weed growth and allow the native seed to germinate and become established. The warm season grass and forb seeding mix will provide ideal cover for ground nesting waterfowl and upland bird species. The seed mix includes 20 species of native forbs that will attract insects that young birds require. To further increase the attractivness of this area for ground nesting species, our project will include the removal of trees and shrubs that serve as avian predator perches. Research has shown that several species of ground nesters will avoid or under-utilize grasslands with trees. We will contract tree removal through the Minnesota Conservation Corps (MCC). All hardwood trees and shrubs will be flush-cut using chain saws and the stubs will be treated with herbicide to control re-sprouting.


