MINNESOTA DNR VOLUNTEER AGREEMENT

Notice of Intent to Collect Private Data: Data about you as a DNR volunteer is classified as Personnel Data, Minnesota Statutes, section 13.43. Data classified as public data is listed under MS s 13.43, subd.2; all other data about you is classified as private data. All volunteers are asked to provide private data, which includes your address, telephone numbers, email address, and gender, in order to facilitate your volunteer placement. You are not legally required to provide private data. However, if you do not provide the data: we may not be able to contact you; you may not receive important documents; and we may not be able to appropriately place you for volunteer activities. Those who are allowed access to your

private data include: DNR staff who work with volunteers; DNR staff whose work reasonably requires access; and anyone authorized by law or court order.

DNR Staff: Some of the data collected on this form are classified as private data. Only those with a business need to know may have access to the data and it may only be used for activities related to volunteering. Data on this form may not be released to others without first consulting the Human Resources Bureau. This agreement is used to officially register your volunteers for liability coverage. <u>Keep this in YOUR files</u>. Provide a copy of "Notice of Enrollment in a Certified Managed Care Plan for Workers' Compensation Injuries and Illness" to volunteer to read.
