Cottonwood	City of	CW Reishus Park	The project updates facilities, improves access, and restores natural resource values. This project includes a new splashpad, playground, fishing dock, and shelter house (with restrooms, shower and picnic shelter).	\$350,000

Fridley	City of	Commons Park	This project proposes to add an accessible splash pad and associated amenities to Commons Park as part of a park redevelopment project.	\$350,000
La Crescent	City of	Wieser Park	The City of La Crescent is proposing to install a new ADA accessible playground at Wieser Park and two new Pickle Ball courts adjacent to the Wieser Park Pavilion.	\$166,116
Madison	City of	Theodor S. Slen Park	Replacement of two tennis courts and one basketball court, plus the addition of pickleball court striping, ADA walk connections, a parking lot, and hydration station that improve	\$350,000
Mahnomen	City of	River Park	The City wishes to add an ADA accessible fishing pier, rip rap for erosion prevention, expanded parking lot, lighting, interpretive signage, and a 9-hole disc golf course to a non-active park.	\$66,750

Wabana	Township of	Wabana Recreation Complex	Project includes construction of basketball, tennis, and pickleball courts. It also includes construction of new ADA accessible walkways that will connect all existing and new amenities within the Wabana Recreation Complex.	\$155,000
White Bear Lake	City of	Lakewood Hills Park	Paving trails that are currently compacted dirt/gravel to improve accessibility throughout the park, establishing a year round trail system on the south side of the city.	\$224,140
