

Minnesota Native Prairie Tax Exemption

The Native Prairie Tax Exemption, administered by the Minnesota Department of Natural Resources (DNR) and the Department of Revenue, encourages landowners to preserve native Minnesota prairie. Your qualifying prairie acres are exempted from property taxes as long as this land meets the criteria below.

Native Prairie Criteria

- Land dominated throughout by native prairie vegetation and limited to no tree cover. A local
 Department of Natural Resources staff will determine if land is native prairie based upon the number of
 native prairie plants found on the site.
- 2. Land is at least 5 contiguous acres. Smaller parcels may qualify if they provide important rare species habitat or contain other significant prairie features.
- 3. Land not used for grazing.
- 4. Land used for haying once a year may qualify. If hayed this year, indicate approximate date on form.
- 5. Land is in an eligible county (excludes Lake of the Woods, Koochiching, Itasca, St. Louis, Lake, Carlton, and Pine Counties).

In addition, this land must not have been severely altered by:

- 1. Plowing, grazing, or seeding with non-native plants.
- 2. Spraying with herbicides. Spot spraying once a year may still qualify.

How to Apply for Native Prairie Tax Exemption

- 1. Fill out the application below.
- 2. Obtain 2 USDA Farm Service Agency (FSA) or similar aerial photos of this land. Outline prairie in red.
- Email the completed application and 2 aerial photos to <u>prairie.protection@state.mn.us</u> or mail to MN DNR, Attn: Prairie Biologist, 246 125th Ave NE, Thief River Falls MN 56537

What Happens Next?

Local DNR staff will contact you to field check the prairie and determine whether it qualifies. Once enrolled, your Native Prairie Tax Exemption will automatically be renewed each year. Enrolled tracts are subject to periodic review to ensure the property still meets eligibility criteria. You are responsible for notifying the County Assessor in writing if you change condition of the property such that it no longer meets the criteria listed above – for example, if you plow, plant trees, or begin grazing the prairie.

If you sell the property, the exemption carries over to the new owner. Please remember to tell them about it.
