Pursuant to Minn. Stat. § 84.027, subd. 2, and 88.22, subd. 1a, and the authority delegated to me by the Commissioner of Natural Resources under Commissioner's Delegation Order No. 2028, 2029, 2030, it has been determined necessary to close the following forest roads or trails:

REASON FOR CLOSING: The roads and trails listed in this Order are closed for the following reason(s) (Check applicable box(es)):


- The road or trail is located within the wildfire areas, conditions conducive to wildfire hazards exist, and the presence of persons in the areas tends to aggravate wildfire hazards. Minn. Stat. § 88.22.
- Conditions render forest road and trails impassable if they are driven on during wet seasons. Minn. Stat. § 88.22
- To prevent damage to forest roads, trails or adjacent lands. Minn. Stat. § 88.22.
- Presence of persons hampers the effective enforcement of state timber trespass and game laws. Minn. Stat. § 88.22.

PERMANENT RESIDENTS: Permanent residents wishing to obtain permission to travel to and from their homes on the closed road/trail, must contact the forest officer at the address listed below.

PENALTIES: Violation of any order issued under Minn. Stat. §88.22 is a misdemeanor. Violations constituting willful trespass under Minn. Stat. § 90.301 are a gross misdemeanor. Other criminal and civil penalties, as provided by law, may also apply.

POSTING: A sign shall be posted on the road/trail closed by this Order to inform users of these restrictions.
