Mille Lacs Band v. Minnesota Status of Phase II Regulatory Issues June 5, 1996

This table lists the particular State statutes and regulations challenged by plaintiffs and plaintiff-intervenors in the current phase of the litigation. Plaintiffs and plaintiff-intervenors may challenge additional statutes or regulations in the future, to the extent that in practice they interfere with the plaintiff and plaintiff-intervenor Bands' treaty hunting, fishing and gathering rights. However, any such challenge shall be addressed in accordance with the dispute resolution procedures adopted by the Court.

Each challenged statute or regulation is classified as "Resolved" or "Unresolved". Except as otherwise provided below, "Resolved" means that the stipulating parties (plaintiffs, plaintiff-intervenors, and defendants) agree that, upon adoption of the Band Code (Exhibit A), issuance of the Band Commissioner's Orders (Exhibit B), and approval of the Band Management Plans (Exhibit C) and State-Band Protocols (Exhibit D) by one or more of the plaintiff or plaintiff-intervenor Bands, the listed statute or regulation shall not be applicable to such Bands' and their members' hunting, fishing and gathering activities in the Minnesota Ceded Territory or to their possession, transportation, use or disposition outside of the Minnesota Ceded Territory of fish, game or plant resources harvested within the Minnesota Ceded Territory.

"Unresolved" means that defendants contend that the application to Band members of the challenged statute or regulation either (1) is necessary for conservation, public health or safety, as those terms are used in the Court's Phase I decision, notwithstanding the provisions of the Band Code, Commissioner's Orders, Management Plans and Protecols, or (2) applies on lands on which the Bands' treaty right is not applicable. The Comments column indicates the nature of defendants' contention. Plaintiffs and plaintiff-intervenors dispute these contentions and the dispute will be presented to the Court for resolution on summary judgment motion or at trial.
