Thank you for the opportunity to comment on the above project. Information received in our office on 16 March 2017 has been reviewed pursuant to the responsibilities given the Minnesota Historical Society by the Minnesota Historic Sites Act and the Minnesota Field Archaeology Act.

We have reviewed the cultural resources survey report *Cultural Resource Reconnaissance Survey for a Native Soil Mountain Bike Trail Project, Cuyuna Country State Recreation Area, Crow Wing County, Minnesota* (March 2017) that was prepared for this project. Based on the results of the survey, we conclude that there are no known or suspected archaeological properties in the area that will be affected by this project.

As you are aware, this bike trail project is located within the boundaries Cuyuna Iron Range Historic Mining Landscape District (District), which has previously been determined eligible for listing in the National Register of Historic Places (NRHP). Based on the information provided, it appears as though many of the features identified in the initial evaluation of this District (stockpiles, mine shafts, structures, foundations, roads and railroads), within and near the proposed project area, have been compromised due to demolition activities after the mines fell out of use. As long as all of the associated building and non-railroad grade structural remains that were identified during the reconnaissance survey are avoided, and as long as the project's impacts on the stockpiles, roads and railroad grades will be minimal and reversible as stated in the report, we concur with your determination that this project will have no adverse effect on the Cuyuna Iron Range Historic Mining Landscape District. We note that the Ironton Sintering Plant, which is listed in the NRHP, is located nearby but will not be visible from the proposed project. We agree with your determination that this project will have no effect on this historic property.

Please note that this comment letter does not address the requirements of Section 106 of the National Historic Preservation Act of 1966 and 36 CFR § 800. If this project is considered for federal financial assistance, or requires a federal permit or license, then review and consultation with our office will need to be initiated by the lead federal agency. Be advised that comments and recommendations provided by our office for this state-level review may differ from findings and determinations made by the federal agency as part of review and consultation under Section 106.

Dear Mr. Gimmestad:

We have reviewed the above-referenced undertaking in accordance with our FHWA-delegated responsibilities for compliance with Section 106 of the National Historic Preservation Act (36 CFR 800) and the 2005 Section 106 Programmatic Agreement among the FHWA, the SHPO, and the USACOE.

The FHWA is providing funds to the Minnesota Department of Natural Resources, Division of Parks and Trails (DNR), to construct approximately 21 miles of mountain bike trails within the Cuyuna Country State Recreation Area (CCSRA). These trails are within the tentative boundaries of the Cuyuna Iron Range Historic Mining District, which the Mn/DOT Cultural Resources Unit (on behalf of the FHWA) has considers eligible for the National Register of Historic Places (see S.P. 18-090-01; SHPO No. 2003-1729).

The specific details of construction are contained in State Park Archaeologist Dave Radford's 7-23-09 letter report to me and its attachments (these were copied to you by Mr. Radford). The trail has been designed to cause minimal disturbance during construction and to minimize erosion. The trail treadwith will average four feet, but may be expanded up to five feet in some areas. There will be limited cutting and filling, and the trail will have a compacted native soil surface. Grubbing of secondary growth vegetation will be required along the trails to varying degree; typically, cleared areas will extend two feet to either side of the trail (for a typical cross section, see Sheet 4 of the draft review plans attached to the 7-23-09 letter from Radford to Abel). The principal equipment to be used in building the trail will be a four- to five-foot walkbehind dozer (see Sheet 12 of the draft review plans).

The CCSRA is currently used for recreational purposes; therefore, we do not believe that the introduction of mountain bike trails will affect an area larger than the proposed trail construction corridor. The project area of potential effects (APE) includes 25 feet to either side of the trail centerline. There are no known archaeological resources within the project APE. The land to be used for the trails has been intensively disturbed by historical mining activities and is unlikely to contain intact and significant precontact archaeological resources. The proposed trails fall within

the tentative boundary of the Cuyuna Iron Range Historic Mining District, considered eligible for the National Register of Historic Places, and within the National Register boundary of the listed Ironton Sintering Plant (see Figure 5 attached to the 7-23-09 letter from Radford to Abel). In addition, the trails will be built in the vicinity of the Croft Mine (CW-CSC-015).

MnDNR Review

State Park Archaeologist Dave Radford completed a limited review of the archival materials pertinent to this undertaking as well as several field surveys. Mr. Radford identified several areas within the project APE where cultural features related to mining are known or are likely to be found. As described in his 7-23-09 letter report to me, Mr. Radford field surveyed these areas and recorded any cultural features present with a Trimble Pro XR GPS unit. This information resulted in the rerouting of the proposed trails in some areas to avoid mining features (the GIS data has been forwarded to Brauer and Associates, who are preparing the construction plans for this project). The trail in the vicinity of the National Register-listed Ironton Sintering Plant will skirt the eastern edge of the property along the snowmobile route reviewed by our office in 2003 (SHPO No. 2003-1729). In the vicinity of the Croft Mine, the proposed trail alignment will be routed well northwest of the identified historic features, and we concur with Mr. Radford that the trails will not adversely affect visual or auditory characteristics of these sites.

Need for a Historic Context

Because the Cuyuna Iron Range Historic Mining District has not been the subject of a comprehensive study, not much is known about the specific features it contains or their historic context, other than that many are unique historical resources. The Works Projects Administration's *The Cuyuna Range: A History of a Minnesota Iron Mining District* (Anna Himrod, The Minnesota Historical Records Survey Project, 1940) is a helpful source for understanding the history of the Cuyuna Range up until its date of publication, but does not cover the World War II or post-war eras on the range. A well-developed historic context for the Cuyuna Iron Range is well beyond the limited scope of the present undertaking. However, the archival materials identified through Mr. Radford's efforts provide a solid foundation on which to develop a historic context that would be extremely useful in future CCSRA planning and management decisions as well as environmental reviews.

Finding

Mr. Radford made several recommendations in his 7-23-2009 letter report regarding additional measures to ensure that the trails do not impact any cultural resources. These conditions are:

- 1. The contractor will attend a preconstruction meeting with MnDNR staff and an archaeologist from the Minnesota State Park Cultural Resource Management Program. The archaeologist will give a presentation at the meeting on the historical significance of the project area and show the contractor mining features in the field so they can recognize them.
- 2. The construction plans will indicate that if the contractor encounters historic features, they will stop ground disturbance in the area and contact the project manager or the archaeologist assigned to the project. The contractor will avoid working in that area until

clearance is given based on a field assessment by the archaeologist assigned to the project.

- 3. The contractor will inform the archaeologist assigned to the project of any significant changes in trail alignments and such changes must be approved by the archaeologist prior to construction.
- 4. The archaeologist assigned to the project will be available to monitor construction on an as-needed basis. In addition, CCSRA Manager Steve Weber, who is familiar with many of the area's cultural features based on extensive experience at the CCSRA, will be closely reviewing construction in the field and will be available to be of assistance as needed.

Provided the above measures are carried out, we concur with Mr. Radford's recommendation that the proposed bike trails will have **no adverse effect** on the National Register-eligible Cuyuna Iron Range Historic Mining District or the National Register-listed Ironton Sintering Plant. Although not a condition of our finding, we also concur with Mr. Radford's recommendations that the historic mining resources within the CCSRA provide excellent opportunities for the MnDNR to interpret the unique history of Cuyuna Range mining to trail and other recreation area users.
