The Minnesota Department of Natural Resources (MDNR) has prepared the Environmental Assessment Worksheet (EAW) for the proposed Minntac Mine Extension Project, located in Mountain Iron, MN. The EAW describes the environmental effects associated with the proposed project and has been prepared pursuant to Minnesota Rules Part 4410.4300, subpart 11, item B. The MDNR is the Responsible Government Unit (RGU) for environmental review of the project. United States Steel Corporation, Minnesota Ore Operations (U.S. Steel) is the Project Proposer.

The proposed project consists of a 483-acre extension of the Minntac open pit mining facilities in Mountain Iron. The extension will extend mine life and taconite production to 2031. Taconite produced from the extension will continue to be processed at the existing Minntac facility at the current levels of production.

The MDNR invites comments on the EAW during the public comment period that begins with publication of the Notice of Availability in the EQB Monitor August 6, 2012, and ends September 5, 2012 at 4:30 P.M.
