## Description of Changes:

The DNR will designate several short ORV/ATV/OHM connections throughout the forest. These connections will be open to previously allowed uses. When used with existing trails and forest roads, these connections will provide a variety of loops for users. The DNR will designate approximately 1.6 acres as an OHV warm up area. The boundaries of this area will be signed and use of the terrain to practice hill maneuvering and safe OHV operations will be allowed. The DNR will also designate several miles of ATV/OHM trails. These trails will consist of new trail, former access routes, change from MMR designation and duel designation with MMRs. The newly designated OHV miles will be in addition to the currently designated 238 miles of OHV trail.

The DNR will undesignate approximately 1.3 miles of trail that are unsustainable, redundant or do not provide good recreational opportunity. These routes will remain open as access routes. Finally, the DNR will designate 10.54 miles of walking trails. 1.8 miles of walking trail will be on access routes currently open to motorized use and will retain historic use. 1.23 miles of walking trail will be duel-designated MMR.

## **Implementation:**

The new designations and changes in designation will be effective after public review and the commissioner's orders have been finalized. Routes that are currently open as access routes will remain in that status until signing and improvements are made. New trails will not be open for use and new trail uses will not be allowed until the DNR completes trail construction and signs the trails open over the next several seasons.

ATV = All-terrain vehicle

OHM = Off-highway motorcycle

ORV = Off-road vehicle (includes 4-wheel drive vehicles; does not include ATVs/OHMs)
