Well Interference Fund Reimbursement Application

The Minnesota Department of Natural Resources (DNR) well interference fund reimbursement provides funds to domestic well owners, public and private water suppliers and high-capacity water appropriators for actual costs incurred due to a domestic well or public or private water supplier out-of-water situation between May 1, 2021 and December 30, 2021. Eligible applicants may receive reimbursement for costs paid to restore a water supply for a domestic well owner or public or private water supply including a newly constructed well, dropping a well pump depth to access water, and adding additional drop pipe to access water at greater depths of the aquifer.

There are two options for submitting your application and copies of your receipts to the Minnesota DNR:

- PREFERRED: Submit your completed application, a brief description below, your well information (well log or well and boring report), the IRS W-9 form, and copies of your receipts via email to droughtwellfund.dnr@state.mn.us.
- Mail your completed application, well information (well log or well and boring report), the IRS W-9 form and copies of your receipts to the Minnesota Department of Natural Resources, Well Interference Fund Reimbursement Box 25, 500 Lafayette Road, St. Paul, MN 55155

What is the Well Interference Fund Reimbursement?

The Minnesota DNR received legislative funding at the end of the 2022 session to reimburse domestic well owners, public and private water suppliers and high capacity water appropriators for costs associated with restoring a water supply due to a well interference. A well interference is described as when a pump draws water from a well and causes the water level in the surrounding aquifer to go down. Sometimes the water level falls below the reach of other, shallower wells, and those wells go out of water. When that happens it is called a well interference. If a domestic well owner, public or private water supplier or a high capacity water appropriator paid for costs to restore a water supply due to well interference between May 1, 2021 and December 30, 2021 then they may be eligible for reimbursement. The DNR has \$300,000 to reimburse people and communities affected by high capacity water appropriation well interference during the drought in 2021. Applicants will need to provide receipts of costs incurred to repair, improve or construct a new well due to a well interference.

Who may apply?

Domestic well owners, public or private water suppliers and high capacity water appropriators who paid for costs to restore a water supply for a domestic well owner or public or private water supply due to a well interference during the time period in 2021 are eligible. People assisting domestic well owners, water suppliers and high capacity water appropriators may also apply on their behalf. A domestic well owner may have paid all or part of the costs to restore the water supply for their home. High capacity water appropriators may have paid all or part of the costs to restore a water supply for a domestic well owner or public or private water supplier due to their high capacity pumping interfering with the ability to access water during the eligibility period in 2021.

How do I apply?

Complete the application with a brief description above including the IRS Form W-9, information on the well (i.e., well log or well and boring report) that was interfered with and submit it to the DNR. The application must include an itemized list of costs incurred, including receipts and may be submitted via email or USPS mail. What types of expenses are eligible?

Any expenses incurred for restoring a water supply for a domestic well owner or public or private water supply are eligible for reimbursement. If a high capacity water appropriator interfered with a domestic well owner or public or private water supply during the 2021 eligibility period, then costs paid to a well contractor for parts or labor to restore a water supply would be accepted. This includes, dropping a pump deeper in the well, adding drop pipe to the well, constructing a new well to replace the well that was interfered with. You must itemize the list of activities with the associated costs charged by a well contractor or similar contractor to improve or replace your well.

Ineligible costs include:

- Those incurred for improving or replacing a domestic well that was not due to a well interference during the eligible time period in 2021.
- Those already paid by MDA through their 2021 Agricultural Drought Relief Program.
- Those incurred by a high capacity water appropriator during the eligibility period who did not have authorization through an active DNR permit to appropriate water; unpermitted pumping.

Privacy Notice

The information provided as part of the Well Interference Reimbursement Fund application will be used to assess the applicant's eligibility to receive payment under this program and to fulfill application financial reporting requirements. Completing this application is voluntary; applicants are not legally required to provide DNR with the information requested, but only completed applications will be considered. While much of the information applicants provide is classified by Minnesota law as public, some of the information may be classified by law as private or nonpublic at Minnesota DNR. Data classified as private or nonpublic will be accessible only to DNR employees that have a work assignment that requires access to the data, and to other entities authorized by law to receive the data. The DNR may be obligated to provide the data to law enforcement agencies, the Minnesota Department of Administration, Minnesota Management and Budget, the Office of the State Auditor, or the Office of the Legislative Auditor. If necessary to commence or defend a legal proceeding, the data may be shared with the Minnesota Attorney General's Office and Minnesota or federal courts. Finally, private data about you or nonpublic data about your business may be released to third parties through your informed consent, or pursuant to a valid court order or subpoena that requires such disclosure.

Internal Revenue Service code Section 6109 requires applicants to provide their correct taxpayer identification number to payers who must file information returns with the IRS. The DNR will use the information provided on the applicants W-9 form to report payments received as part of this program to the IRS. The IRS uses the numbers for identification purposes and to help verify the accuracy of the applicant's tax return.
