### MINNESOTA DEPARTMENT OF NATURAL RESOURCES General Permit 2015-006

Authorization to Transport Aquatic Plants and Prohibited Invasive Species to a Disposal Location

(Minnesota Statutes 84D.05 Subd. 1(5) and 84D.11 Subd. 2d)

**Eligible Permittees:** Commercial entities such as lawn service, beach cleaning, or waste hauling contractors who transport aquatic plants and attached prohibited invasive species.

#### **Non-eligible Permittees:**

- Individuals or businesses who install, remove, decontaminate or rent water-related equipment for hire or as a benefit of membership in an organization are required to have a lake service provider permit: <a href="https://www.dnr.state.mn.us/lsp/index.html">www.dnr.state.mn.us/lsp/index.html</a>.
- This permit is not for use by commercial mechanical control companies.
- Businesses who harvest aquatic plants for sale are required to have an aquatic plant management permit: http://www.dnr.state.mn.us/apm/index.html.

**Disposal Locations:** Approved locations that are listed on Notification & Verification Form

**Scope:** This general permit authorizes commercial entities (i.e. lawn service, beach cleaning, or waste hauling contractors) to transport: aquatic plants with or without attached prohibited invasive species from riparian property to a disposal location. This general permit allows for transport between multiple collection sites before transporting to a disposal site and is valid for one calendar year.

**Conditions:** The permittee must take the following measures to prevent the spread of aquatic invasive species during transport and disposal activities covered under this permit:

- remove excess water from the aquatic plants and attached material prior to transporting;
- secure the aquatic plants and other material in a covered trailer, closed container or use another method that ensures that plants will remain contained during transport;
- lawfully dispose of all the plants and attached material at least 300 feet from shoreland areas, ditches or seasonally flooded lands; and
- thoroughly clean all aquatic plants and prohibited invasive species from the hauling equipment (e.g., trailer, pickup truck, tarp) before leaving the disposal site.

**Instructions:** The business owner must complete and sign this permit and send a copy to:

The permittee and employees must carry a completed and signed form while transporting aquatic plants or prohibited invasive species to a disposal location.

**Penalties:** Violations of this permit can result in civil and criminal penalties established in Minnesota Statutes, chapter 84D.13.

**Revocation:** The commissioner may modify or revoke this permit in accordance with applicable laws and rules for any cause as necessary for the protection of public interests, or for violation of the provisions of this permit.
