



General Permit: Herbarium Specimens of Plants

Who needs to follow this general permit

If you have herbarium specimens of any of the prohibited invasive species of plants or algae listed below, maintained as part of a herbarium associated with a research, education, or government organization, you may possess, transport, and purchase those specimens according to the conditions below.

How to use this general permit

You do not need to keep a copy of this permit. You do need to read and follow the permit conditions below. Please check the DNR's [aquatic invasive species permit website](#) and sign up for permit updates to learn about changes to this permit.

Permit conditions

Species:

This permit applies only to herbarium specimens of prohibited invasive species that are plants or algae and listed in [Minnesota Rules, 6216.0250](#), subp. 2 and 2a, including hybrids, cultivars or varieties of:

African oxygen weed (<i>Lagarosiphon major</i>)	Indian swampweed (<i>Hygrophila polysperma</i>)
aquarium watermoss or giant salvinia (<i>Salvinia molesta</i>)	purple loosestrife (<i>Lythrum salicaria</i> , <i>Lythrum virgatum</i> , or any variety, hybrid, or cultivar thereof)
Australian stonecrop (<i>Crassula helmsii</i>)	starry stonewort (<i>Nitellopsis obtusa</i>)
brittle naiad (<i>Najas minor</i>)	water aloe or water soldiers (<i>Stratiotes aloides</i>)
curly-leaf pondweed (<i>Potamogeton crispus</i>)	water chestnut (<i>Trapa natans</i>)
Eurasian watermilfoil (<i>Myriophyllum spicatum</i>)	plants on the Federal noxious weed list (CFR title 7, section 360.200), except Chinese water spinach (<i>Ipomoea aquatica</i>)
European frog-bit (<i>Hydrocharis morsus-ranae</i>)	
flowering rush (<i>Butomus umbellatus</i>)	
hydrilla (<i>Hydrilla verticillata</i>)	

Authorized use:

You may possess, transport, and purchase herbarium specimens for educational or research purposes if the specimens are part of a herbarium maintained in association with an educational, research, or government organization or institution. Failure to comply with this permit may be a violation of *Minnesota Statutes*, 84D.05.

Other jurisdictions:

This permit applies to your use of the herbarium specimens in Minnesota. You may need other state, provincial, or federal permits outside of Minnesota.

Dates valid:

This permit is valid December 22, 2017-December 31, 2019.
