2017 Authorization to Print Help Stop Aquatic Hitchhikers! Signs

The Minnesota Department of Natural Resources (DNR) allows representatives of lake associations, local governments, and other groups to print their own "Help Stop Aquatic Hitchhikers!" and "Dispose Here" signs to post at water accesses.

Instructions: Review the instructions on the DNR website. You must:

- 1. Receive permission from the water access owners. Find ownership information using LakeFinder.
- Complete the form below (pgs. 1 & 2) and provide a copy to the company printing the DNR signs. Send a copy to the DNR at 500 Lafayette Road, Box 25, St. Paul MN 55155, "ATTN: AIS sign printing" or email an electronic copy to <u>tina.wolbers@state.mn.us</u>.
- 3. Provide your printer with the artwork files by directing your printer to the DNR website.
- 4. Review the Aquatic Invasive Species Sign Manual for installation guidelines.
- 5. Submit the AIS Sign Installation Report Form (pg.3) to the DNR within 60 days of sign installation.
